**ACT SUMMARY**

- Authorizes the issuance of an International Association of Firefighters license plate inscribed with a Maltese cross emblem.
- Prohibits any person who is not a member in good standing of the International Association of Firefighters from having International Association of Firefighters license plates.
- Prohibits any person who is not a member in good standing of the International Association of Firefighters from representing that he is such a member to obtain the license plates.

**CONTENT AND OPERATION**

**International Association of Firefighters license plates**

(sec. 4503.471(A) and (C))

Under the act, any person who is a member in good standing of the International Association of Firefighters may apply to the Registrar of Motor

Vehicles for the registration of any passenger car, noncommercial motor vehicle, motor home, or other vehicle of a class approved by the Registrar that the person owns or leases and may obtain International Association of Firefighters license plates. (See **COMMENT**.)

The application for the license plates must be accompanied by written evidence, as required by the Registrar by rule, showing that the person is a member in good standing of the International Association of Firefighters. The application for the license plates may be combined with a request for a special reserved license plate (also commonly known as "vanity plates") provided in continuing law.

Upon receipt of the completed application, payment of the applicable taxes and fees as explained below, and presentation of the evidence showing that the person is a member in good standing of the International Association of Firefighters, the Registrar is required to issue to the applicant the appropriate vehicle registration and a set of International Association of Firefighters license plates with a validation sticker, or a validation sticker alone once the person already has International Association of Firefighters plates.

In addition to the letters and numbers ordinarily inscribed on license plates, International Association of Firefighters license plates must be inscribed with a Maltese cross emblem designed by the International Association of Firefighters and approved by the Registrar. The license plates must bear county identification stickers that identify the county of registration by name or number.

International Association of Firefighters license plates and validation sticker are issued upon payment of the regular state and local taxes and fees prescribed in continuing law, a fee of \$10 for the purpose of compensating the Bureau of Motor Vehicles for additional services required in the issuing of International Association of Firefighters license plates, and compliance with all other applicable laws relating to the registration of motor vehicles. If the application for International Association of Firefighters license plates is combined with a request for a vanity plate, the applicant also must pay the additional fee specified for those plates. The Registrar is required to deposit the additional \$10 fee in the State Bureau of Motor Vehicles Fund.

Whenever a person no longer is eligible for the International Association of Firefighters license plates, the act requires the person to surrender the plates in

exchange for other license plates and authorizes a \$5 fee to be charged for issuing the replacement plates.<sup>1</sup>

### **Prohibitions**

(secs. 4503.471(B) and 4503.99(A))

The act prohibits any person who is not a member in good standing of the International Association of Firefighters from willfully and falsely representing that the person is a member for the purpose of obtaining International Association of Firefighters license plates. Also, no person may own or lease a vehicle bearing International Association of Firefighters license plates unless the person is eligible to be issued the license plates. Violation of either of these prohibitions is a misdemeanor of the fourth degree.

### **COMMENT**

Membership in the International Association of Firefighters is limited to persons employed as firefighters or who retired from such employment.
