**BILL SUMMARY**

- Beginning January 1, 2001, increases the base salary of members of the General Assembly from \$42,427 to \$44,927 and also increases the salaries for members in leadership positions and the supplements paid to members who serve in specified positions on standing committees and subcommittees.
- Provides for additional increases every other year beginning January 1, 2003, based on the lesser of 3% or increase in the Consumer Price Index.

---

**CONTENT AND OPERATION**

The bill increases the compensation of members of the General Assembly, including the base pay, the salaries of members in leadership positions, and the supplements paid to members who hold specified positions on standing committees and subcommittees. The increases do not apply until January 1, 2001.

The following table lists the current salaries of members and officers of the General Assembly, and the salaries specified in the bill for 2001:

The following table lists the committee positions for which additional pay is received, the current additional compensation, and the additional compensation specified in the bill for 2001. The table applies to both chambers.

The bill provides for regular increases every other year in members' and officers' salaries, and the committee supplements, beginning on January 1, 2003. The amount of the increase is the lesser of 3% or the percentage increase in the Consumer Price Index for the preceding year.
