ACT SUMMARY

- Designates July 9 as "Traumatic Brain Injury Awareness Day."

CONTENT AND OPERATION

Traumatic Brain Injury Awareness Day

The act designates July 9 as "Traumatic Brain Injury Awareness Day" for the purpose of increasing public awareness of traumatic brain injuries.¹ The act specifies that the General Assembly joins with the following nonprofit organizations in recognizing the importance of efforts to increase public awareness of traumatic brain injuries:²

--BrainSong, which is an organization founded by a traumatic brain injury survivor with an extensive musical background to advocate for women whose lives have been affected by traumatic brain injury;³

--The Brain Injury Association of Ohio, which is a statewide advocacy and education organization created to improve services and supports for Ohioans with brain injury and their families and to promote prevention.⁴
