OVERVIEW

Agency Overview

The primary purpose of the Ohio Commission on Hispanic/Latino Affairs (OCHLA) is to advise the Governor, General Assembly, and state agencies on policies focusing on the special issues and needs of Ohio's Spanish-speaking population. The governing authority consists of 11 members appointed by the Governor. Of the 11 members, the Speaker of the House of Representatives and the President of the Senate each recommend two for appointment, and the minority leaders of the House and Senate each recommend one for appointment. Members are required to be of Latino heritage and to be able to speak minimal Spanish. OCHLA's daily operations are the responsibility of an executive director, appointed by the governing authority, and three full-time and two part-time employees.

Appropriation Overview

The budget provides funding of \$469,953 in FY 2018, 13.9% above FY 2017 spending levels, and funding of \$484,943 in FY 2019, 3.2% above FY 2018 levels.

Operating Expenses (148321)

This line item supports OCHLA's personnel expenses for its three program offices (the Public Policy Center, Latino Community Network, and Organizations Development Center) as well as OCHLA's other operational expenses, which include computer software and hardware upgrades, rent, and supplies. This line item also supports various initiatives involving community projects geared toward Latino populations in the state. Historically, these outreach activities have been conducted in eight regions throughout the state: Toledo, Fremont, Lorain, Cleveland, Youngstown, Columbus, Dayton, and Cincinnati. OCHLA also maintains the Ohio Latino Affairs Network (OLAnet) database system, which helps to enhance economic growth, connect Latino communities, and provide information and news about Latino events statewide.

The budget combines the two separate GRF line items (148100, Personal Services, and 148402, Community Programs) that formerly funded these costs into a single line item, which may give SPA more flexibility in the use of its GRF appropriations. For the new line item, the budget provides \$445,395 in FY 2018, an 11.6% increase from the total FY 2017 spending of SPA's two former GRF line items, and \$460,385 in FY 2019, a 3.4% increase when compared to the FY 2018 appropriation.

Special Initiatives (148602)

This line item mostly supports expenses related to the Minority Health and Latino Health programs and the annual Distinguished Hispanic Ohioan Award Gala. The budget provides nearly \$25,000 in each fiscal year for this line item, an increase of nearly \$11,000 compared to FY 2017 spending.
