

Introduction

Section 103.13(H) of the Revised Code requires the Legislative Service Commission (LSC) to prepare a report each year evaluating the extent to which Ohio's various occupational licensing and regulatory boards and commissions are financially self-supporting. This report summarizes the year-end cash balances for funds used by 40 such boards and commissions in FY 2008 (July 1, 2007 through June 30, 2008). These 40 boards and commissions used a number of different state funds as operating accounts into which their receipts were deposited and from which their expenses were paid. As of June 30, 2008, the 21 funds used primarily by the boards and commissions had a combined cash balance of \$68.7 million compared to the combined cash balance of \$66.4 million as of July 1, 2007. As of June 30, 2008, the boards and commissions also encumbered a total of \$2.5 million FY 2008 funds to be spent in FY 2009, leaving the funds with a combined unobligated cash balance of \$66.2 million. On the individual fund level, none of the 21 funds finished FY 2008 with a negative cash balance. In other words, collectively, these 40 boards and commissions had sufficient revenues to cover their expenditures and were financially self-supporting in FY 2008.

The report is divided into three sections. Section I provides a simplified cash balance statement for the 21 funds used by the boards and commissions in FY 2008 and summarizes revenue and expenditure patterns of the boards and commissions. Section II compares the total number of active licenses for each board or commission in FY 2008 with that in FY 2007. Section III provides some additional operating statistics, such as the staffing levels, and a summary of newly enacted legislative changes affecting the boards and commissions in FY 2008. LSC first obtained the financial data used in this report from the state's accounting system, the Ohio Administrative Knowledge System (OAKS), and then verified the data with the boards and commissions, some of which made changes to that information based on internal financial records. Information concerning licensing activity was provided by the boards and commissions. The Department of Administrative Services' Central Service Agency (CSA), which supports the administrative operations for most of the licensing boards and commissions, also provided assistance.

Section I: Revenues, Expenditures, and Year-End Fund Balances

Year-End Fund Balances

In FY 2008, 40 different boards and commissions regulated and licensed various occupations and professions in the state of Ohio. These boards and commissions did not receive any funding from the General Revenue Fund (GRF). Their operations were primarily supported by license fees plus fines, penalties, and some other assessments. The 40 boards and commissions used 23 different non-GRF funds as operating accounts into which their receipts were deposited and from which their expenses were paid. A fund's cash balance is an indicator of whether an entity is financially self-supporting. Table 1 provides a simplified cash balance statement covering 21 of these funds that are used primarily by the boards and commissions. As of July 1, 2007, the first day of FY 2008, these 21 funds had a combined cash balance of \$66.4 million. During FY 2008, a total of \$65.2 million in receipts were deposited into the funds and a total of \$62.9 million in expenditures were paid out of the funds. As of June 30, 2008, the last day of FY 2008, these 21 funds had a combined cash balance of \$68.7 million and outstanding encumbrances of \$2.5 million, leaving the funds with a combined unobligated cash balance of \$66.2 million.

The largest of the 21 funds is the Occupational Licensing and Regulatory Fund (Fund 4K90), which serves as the operating account for 26 of the 40 boards and commissions. Fund 4K90 finished FY 2008 with a cash balance of \$29.4 million, a decrease of \$1.1 million (3.6%) from its beginning cash balance of \$30.5 million. Taking into account its year-end encumbrance of \$1.1 million, Fund 4K90 finished FY 2008 with an unobligated cash balance of \$28.2 million.² Except for two funds that were closed when the Ohio Medical Transportation Board and the Board of Motor Vehicle Collision Repair Registration transitioned to Fund 4K90, each of the 18 other operating funds also finished FY 2008 with positive unencumbered cash balances.

Revenues and Expenditures

In addition to examining a fund's year-end cash balance, it may be helpful to examine a fund's revenue and expenditure patterns without taking into account the fund's beginning cash balance. A sufficient beginning cash balance may help a board or

commission to absorb an operating deficit during a given year. However, a board or commission with an annual expenditure level consistently exceeding its annual revenue level may eventually have to reduce its expenditures, increase its license fees, or both. Table 2 lists revenues and expenditures for each board and commission at the fund level. It also compares each fund's revenues and expenditures to see whether the revenues generated during a given period were sufficient to cover the expenditures incurred in that period. Nearly all of the revenue received by a board or commission comes from license fees. The license renewal cycle can have a significant impact on the annual revenue intake for a board or commission that does not have an annual renewal cycle.

In order to provide a more complete picture of revenue and expenditure patterns, for those boards and commissions issuing annual licenses, the table lists their funds' FY 2008 revenues and expenditures. For those boards and commissions issuing biennial licenses, the table lists their funds' biennial (FY 2007-FY 2008) total revenues and expenditures. The triennial (FY 2006-FY 2008) totals were used for those issuing triennial licenses. Note that some boards and commissions with biennial or triennial license renewal cycles have staggered their license renewals to prevent their revenues from fluctuating significantly from year to year.

As can be seen from Table 2, of the funds used by boards and commissions to process annual licenses, five funds and the State Board of Optometry portion of Fund 4K90 registered expenditures at levels higher than their revenues in FY 2008. Fund 5530, which was used by the Division of Financial Institutions of the Department of Commerce, had the largest deficit with FY 2008 expenditures exceeding FY 2008 revenues by \$261,000 (6%). Of the funds with FY 2008 revenues exceeding expenditures, Fund 5500, which was used by the Division of Securities of the Department of Commerce, registered the largest surplus with FY 2008 revenues exceeding expenditures by over \$11 million, when a transfer-out of \$8 million to the GRF is not included.

Of the funds used by boards and commissions to process biennial licenses, the Manufactured Homes Commission, which operated out of Fund 4K90, had the largest biennial deficit, approximately \$454,000, while the Board of Nursing, which also operated out of Fund 4K90, had the largest biennial surplus, \$6.7 million.

Of the funds used by boards and commissions to process triennial licenses, Fund 83M0, which was used by the Board of Emergency Medical Services, was the only one that posted a deficit over a three-year period at \$2.7 million, though a transfer-in of approximately \$3.4 million in FY 2006 has bolstered the fund's cash balance. The Division of Emergency Medical Services (EMS) of the Department of Public Safety is the

administrative arm of the Board. The licenses overseen by the Division of Emergency Medical Services carry no fees and therefore generate no revenue. The EMS Division is funded primarily from traffic fine revenue in the Trauma and Emergency Medical Services Fund (Fund 83M0).

It should be noted that the Central Service Agency (CSA) of the Department of Administrative Services provides centralized administrative support to most of the licensing boards and commissions. Services made available through CSA include items such as budget development, Controlling Board request preparation assistance, management consultation, procurement, fiscal processing, human resources, and payroll. These centralized services help increase overall efficiency. CSA charges boards and commissions various user fees depending upon the services rendered.

Occupational Licensing and Regulatory Fund (Fund 4K90)

As indicated earlier, 26 of the boards and commissions covered in this report operated out of Fund 4K90. Fund 4K90 receipts totaled \$27.7 million in FY 2008, a decrease of \$7.3 million (20.8%) from FY 2007. Much of this decrease was due to differences in renewal cycles. The majority of biennial licenses issued by several larger boards and commissions are renewed in odd-numbered fiscal years. Fund 4K90 expenditures totaled \$27.0 million, an increase of \$1.9 million (7.3%) from FY 2007. This increase was primarily due to higher payroll and fringe benefit costs. As regulatory entities, personal service spending, including payroll, fringe benefit, and purchased services, accounted for the largest share (78%) of total expenditures incurred by boards and commissions in FY 2008, followed by supplies and maintenance (19%). The remainder (3%) was for items such as equipment and other miscellaneous expenditures.

Section II: Active Licenses, FY 2007 and FY 2008

Table 3 lists the total number of active licenses for each board or commission for FY 2007 and FY 2008 and the percent change in the total number of licenses between these two fiscal years. Of the 40 boards and commission, 24 boards and commissions reported increases in the number of active licenses, while 15 reported decreases and one reported no change. Four boards and commissions reported increases in active licenses of more than 10% while five reported decreases of more than 10%.

Legislation Effective in FY 2008

All the bills discussed below became effective between July 1, 2007 and June 30, 2008 and were enacted by the 127th General Assembly. Two of these bills affected several of the boards and commissions. The first, H.B. 104, requires certain boards and commissions to conduct criminal background checks on license applicants. The second, H.B. 372, requires boards and commissions to take a more flexible approach in dealing with continuing education requirements that apply to licensees that are on active military duty. These two bills and other relevant enacted legislation are briefly summarized below.

Criminal Background Checks Required for Certain Initial License Applicants

H.B. 104 requires 16 specified licensing boards to carry out criminal records checks on certain license applicants and those applying to restore their licenses. Under this new requirement, these 16 licensing boards may not grant an application for an

initial license unless the applicant requests a criminal records check. The 16 specified licensing boards are the Accountancy Board; State Dental Board; Board of Embalmers and Funeral Directors; State Board of Optometry; Ohio Optical Dispensers Board; State Board of Pharmacy; State Medical Board; State Board of Psychology; State Chiropractic Board; Ohio Construction Industry Licensing Board; State Veterinary Medical Licensing Board; Occupational Therapy, Physical Therapy and Athletic Trainers Board; Counselor, Social Worker, and Marriage and Family Therapist Board; Ohio Board of Dietetics; Ohio Respiratory Care Board; and the State Board of Orthotics, Prosthetics and Pedorthics.

Expired License Exemptions – National Guard and Reserve Members

H.B. 372 requires the state's professional and occupational licensing boards to grant active duty National Guard or reserve members a 31-day extension to fulfill continuing education requirements needed for license renewal. Additionally, the act requires licensing boards to consider relevant education, training, and service completed by licensees serving in the armed forces, reserves, National Guard, Ohio Military Reserve, or Ohio Naval Militia in determining whether licensees have fulfilled their continuing education requirements.

Architects Board

H.B. 119 created the Architecture Education Assistance Program within the Architects Board. The program pays the Intern Development Program (IDP) enrollment fee of \$100 for eligible students enrolled at one of Ohio's four accredited schools of architecture. The IDP is required in order to obtain professional licensure. The Architecture Education Assistance Program is intended to provide an incentive for students to enroll in the IDP as soon as they are eligible so that more students will seek professional licensure and so that graduates will remain in Ohio, helping maintain a stable number of licensed architects in the state.

S.B. 225 changed the name of the State Board of Examiners of Architects to the Architects Board. This act allows several new architectural titles to be used, changes reciprocity requirements, modifies the contents of certificates awarded to licensees, adds a fee to cover the cost of insufficiently funded checks, and expands firm ownership options.

State Chiropractic Board

S.B. 33 authorizes a chiropractor to obtain a certificate to practice acupuncture from the Ohio State Chiropractic Board upon completion of all requirements.

State Medical Board

H.B. 119 authorizes the State Medical Board of Ohio to adopt rules specifying an acceptable examination and establishing the minimum score on that examination that demonstrates proficiency in spoken English for foreign medical graduates wishing to receive a certificate to practice medicine and surgery or osteopathic medicine and surgery in Ohio. The act also increases the time in which the Board must issue a final adjudicative order regarding a summary suspension from 60 to 75 days after the completion of its hearing.

H.B. 314 authorizes the Board to take disciplinary action against a physician if that physician, under certain circumstances, fails to provide a woman receiving an abortion the opportunity to view the active ultrasound image of the embryo or fetus and offer to provide a woman with a physical picture of the ultrasound image of the embryo or fetus.

S.B. 33 permits the Board, subject to Controlling Board approval, to enter into a personal service contract with one or more attorneys admitted to the practice of law in Ohio to serve on a temporary basis as hearing examiners.

State Board of Optometry

H.B. 149 modifies the scope of the practice of optometry in a number of ways. Among other things, the act requires the State Board of Optometry to (1) adopt rules governing the use of Schedule III controlled substances in the practice of optometry, (2) increases the requirement for annual continuing optometric education in pharmacology to ten hours (from five) and applies this ten-hour requirement to all optometrists, and (3) modifies the licensing exemption that applies to optometry students by permitting students from optometry schools in other states to participate in an optometry training program in Ohio.

State Board of Pharmacy

As noted above, H.B. 149 requires the State Board of Optometry to adopt rules governing the authority of optometrists holding therapeutic pharmaceutical agents (TPA) certificates to employ, apply, administer, and prescribe Schedule III controlled substances. These rules must be adopted in accordance with the Administrative Procedure Act (R.C. Chapter 119.) and in consultation with the State Board of Pharmacy.

S.B. 33 modifies the immunity from civil liability, criminal prosecution, and professional liability that applies to persons and government entities for matters related

to donating, giving, accepting, or dispensing prescription drugs under the Drug Repository Program established by the State Board of Pharmacy.

S.B. 58 makes a number of changes to the laws regarding pharmacist immunizations. The act (1) permits pharmacists to administer certain additional immunizations to adults and to administer certain medications to individuals in emergency situations resulting from adverse reactions to immunizations, (2) lowers the minimum age to 14 years (from 18 years of age or older) for individuals to receive influenza immunizations from pharmacists, (3) permits pharmacy interns working under the direct supervision of a pharmacist to administer influenza immunizations to adults, and (4) reduces the number of votes needed for the State Board of Pharmacy to approve and confirm a finding or order resulting from an investigation or hearing undertaken by one or more of the Board members.
