Introduction

Section 103.13(H) of the Revised Code requires the Legislative Service Commission (LSC) to prepare a report each year evaluating the extent to which Ohio's various occupational licensing and regulatory boards and commissions are financially self-supporting. This report summarizes the year-end cash balances for funds used by 40 such boards and commissions in FY 2012 (July 1, 2011 through June 30, 2012). These 40 boards and commissions use a number of different state funds as operating accounts into which their receipts are deposited and from which their expenses are paid. As of June 30, 2012, the 20 funds used primarily by the boards and commissions for operations had a combined cash balance of \$66.7 million, compared to a combined cash balance of \$63.9 million as of July 1, 2011. The boards and commissions also encumbered a total of \$4.5 million in FY 2012 funds to be spent in FY 2013, leaving the funds with a combined unobligated cash balance of \$62.2 million at the end of FY 2012. Collectively, the 40 boards and commissions had sufficient revenues to cover their expenditures and were financially self-supporting in FY 2012.

The financial and licensing data presented in this report was compiled from information provided by the boards and commissions and data from the Ohio Administrative Knowledge System (OAKS). The report is divided into three sections. Section I provides a simplified cash balance statement for the 20 funds used primarily by the boards and commissions for operations and also summarizes their revenue and expenditure activity for FY 2012. Section II compares the total number of active licenses for each board or commission in FY 2012 to FY 2011. Section III provides agency staffing levels, web site addresses, and a summary of newly enacted legislative changes affecting the boards and commissions in FY 2012.

Section I: Revenues, Expenditures, and Year-End Fund Balances

Year-end fund balances

In FY 2012, 40 different boards and commissions regulated and licensed various occupations and professions in the state of Ohio. These boards and commissions did not receive any funding from the General Revenue Fund (GRF). Rather, their operations were supported by license fees, fines, penalties, and other assessments deposited into 23 different non-GRF funds.¹ This section of the report presents a review of cash balances in 20 of these funds at the close of FY 2012, as well as operating income and expenditures for all 23 of the funds over the fiscal year.² This information provides an indication of whether these licensing and regulatory boards and commissions are financially self-supporting.

Table 1 provides a simplified cash balance statement covering 20 of these funds that are used primarily by the boards and commissions. As of July 1, 2011, the first day of FY 2012, these 20 funds had a combined cash balance of \$63.9 million. During FY 2012, a total of \$78.7 million in receipts (including transfers) were deposited into the funds and a total of \$75.9 million in expenditures (including transfers) were paid out of the funds. As of June 30, 2012, the last day of FY 2012, these 20 funds had a combined cash balance of \$66.7 million and outstanding encumbrances of \$4.5 million, leaving the funds with a combined, unobligated cash balance of approximately \$62.2 million. All of the 20 funds finished FY 2012 with positive unobligated cash balances.

In FY 2012, of the \$75.9 million in expenditures made by boards and commissions, \$56.9 million (74.9%) was used for board operations and \$19.0 million (25.1%) was transferred out. Of the amount expended for operations, \$42.1 million (74.1%) was for personal services, which includes payroll, fringe benefits, and purchased services, \$9.1 million (15.9%) was for supplies and maintenance, \$4.7 million (8.3%) was for subsidies for training and education programs, and the remaining \$1.0 million (1.7%) was for equipment and other miscellaneous expenditures.

Of the \$19.0 million transferred out of the funds used by boards and commissions, the largest transfer was \$14.0 million (73.7%) from the Division of Securities Fund (Fund 5500) to the GRF. A transfer from Fund 5500 to the GRF is

generally made each year in accordance with law based on the amount of fees collected by the Division of Securities that are determined by the Director of Commerce and the Director of Budget and Management to be in excess of the Division's expenses. In addition, almost \$4.7 million (24.7%) was transferred out of the Occupational Licensing and Regulatory Fund (Fund 4K90). Of this amount, about \$2.0 million was transferred to funds used by boards for education assistance programs: \$1.7 million to Fund 5AC0, which is used by the Board of Nursing, and \$303,560 to Fund 4J80, which is used by the Accountancy Board. Also, \$1.8 million was transferred from Fund 4K90 to the Ohio Professional Licensing System Fund (Fund 5JQ0) used by the Department of Administrative Services. This transfer was made to fund the replacement of the eLicensing system, which is used by various boards and commissions to manage electronic licensing.

Occupational Licensing and Regulatory Fund (Fund 4K90)

The largest of the 20 funds is the Occupational Licensing and Regulatory Fund (Fund 4K90), which serves as the operating fund for 27 of the 40 boards and commissions covered in this report. Fund 4K90 finished FY 2012 with a cash balance of just under \$19.4 million, an increase of about \$2.0 million (11.1%) from the beginning cash balance of just over \$17.4 million. Taking into account the year-end encumbrance of \$1.2 million, Fund 4K90 finished FY 2012 with an unobligated cash balance of \$18.1 million.³

Fund 4K90 receipts totaled almost \$34.5 million in FY 2012, a decrease of about \$4.2 million (11.0%) from FY 2011 receipts of \$38.7 million. Much of this decrease is due to differences in renewal cycles. The majority of biennial licenses issued by several larger boards and commissions are renewed in odd-numbered fiscal years.

Fund 4K90 expenditures for FY 2012 totaled about \$32.5 million, a decrease of about \$27.0 million (45.3%) from FY 2011 expenditures of \$59.5 million. The difference in expenditures is due to the differences in amounts transferred out of Fund 4K90 in each year. In FY 2011, transfers from Fund 4K90 totaled \$32.3 million (most of this transfer went into the GRF), but in FY 2012, transfers from Fund 4K90 totaled about \$4.7 million. When transfers are excluded, expenditures totaled \$27.9 million in FY 2012, about \$700,000 more than FY 2011 expenditures of \$27.2 million.

Revenues and expenditures

After examining a fund's year-end cash balance, it may be helpful to examine a fund's revenue and expenditure patterns without taking into account the beginning cash balance. While a sufficient beginning cash balance may help a board or commission to absorb an operating deficit during a given year, a board or commission with an annual expenditure level consistently exceeding its annual revenue level may eventually have to reduce its expenditures, increase its license fees, or both. Table 2 lists revenues and expenditures for each board and commission at the fund level. It also compares each fund's revenues and expenditures to determine whether the revenues generated during a given period were sufficient to cover the expenditures incurred in that period. Transfers in and transfers out are excluded from this table in order to view board finances only pertaining to operations.⁴ Nearly all of the revenue received by the boards and commissions covered in this report comes from license fees.⁵ This means that license renewal cycles (generally one, two, or three years) can have a significant effect on annual revenue.

In order to provide a more complete picture of revenue and expenditure patterns for those boards and commissions issuing annual licenses, Table 2 lists their FY 2012 revenues and expenditures by fund. For those boards and commissions issuing biennial licenses, the table lists total revenues and expenditures by fund over the FY 2011-FY 2012 period. Likewise for boards and commissions issuing on a triennial basis, the table lists revenue and expenditure data over the FY 2010-FY 2012 period. Some boards and commissions with biennial or triennial license renewal cycles stagger their license renewal periods to avoid larger fluctuations in revenues and expenditures from year to year.

Annual renewal cycles

As shown in Table 2, in FY 2012, 13 boards and commissions on annual renewal cycles registered higher revenues than expenditures. The Division of Securities in the Department of Commerce, which regulates the sale of securities and licenses security professionals, used two funds: the Division of Securities Fund (Fund 5500), which registered the largest surplus with revenues exceeding expenditures by \$13.9 million,6 and the Investor Education and Enforcement Expense Fund (Fund 5GK0), which had a deficit of \$333,104. Overall, the Division's revenues exceeded its expenditures by

\$13.6 million in FY 2012. In addition to Fund 4K90, the State Board of Pharmacy used six other funds for its programs. The Board's portion of Fund 4K90 had the second largest surplus of \$1.3 million, which was partially offset by deficits in four of the six other funds it used and resulted in a net surplus of \$1.1 million in FY 2012 for the Board. The third largest surplus of \$614,235 was registered by the Ohio Construction Industry Licensing Board in the Industrial Compliance Operating Fund (Fund 5560). The fourth largest surplus of \$513,325 also occurred in Fund 5560, by the Division of Industrial Compliance. Both the Ohio Construction Industry Licensing Board and the Division of Industrial Compliance are located within the Department of Commerce. The Ohio Medical Transportation Board also registered a surplus of \$189,770 in Fund 4K90. All other surpluses for boards and commissions on annual renewal cycles were less than \$100,000 each.

Four boards and commissions on annual renewal cycles registered expenditures at levels higher than their revenues. Three of them registered deficits in their portion of Fund 4K90: the Athletic Commission (\$20,243), the Board of Orthotics, Prosthetics, and Pedorthics (\$3,319), and the Board of Sanitarian Registration (\$3,059). The Division of Financial Institutions registered a deficit of \$2,698 in the Consumer Finance Fund (Fund 5530).

Biennial renewal cycles

Of the 20 boards and commissions that mainly renew licenses on a biennial cycle, 16 registered surpluses and four registered deficits. Three of the largest surpluses were in Fund 4K90. The Board of Nursing's portion of Fund 4K90 had the largest surplus of \$8.5 million followed by the State Board of Cosmetology (\$1.7 million) and the State Board of Registration for Professional Engineers and Surveyors (\$1.0 million); the surpluses for other boards were less than \$1.0 million each. The State Medical Board Operating Fund (Fund 5C60) showed the largest deficit over the past two years of \$1.1 million. Two boards using Fund 4K90 showed deficits: the Ohio Manufactured Homes Commission (\$409,859) and the Board of Speech-Language Pathology and Audiology (\$101,378). The Motor Vehicle Salvage Dealer Licensing Board within the Department of Public Safety had the smallest two-year deficit of \$47,586 in the State Bureau of Motor Vehicles Fund (Fund 4W40).

Triennial renewal cycles

Of the four boards that mainly renew licenses on a triennial basis, two boards registered surpluses over a three-year period: the Accountancy Board (\$1.9 million) in their portion of Fund 4K90 and the Board of Emergency Medical Services (\$1.0 million) in the Trauma and Emergency Medical Services Fund (Fund 83M0). The other two boards within the Department of Commerce registered deficits: the Division of Real Estate and Professional Licensing (\$186,158) in the Division of Real Estate Operating Fund (Fund 5490) and the Board of Building Standards in the Department of Commerce (\$23,469) in Fund 5560.

Section II: Active Licenses, FY 2011 and FY 2012

Table 3 lists the total number of active licenses for each board or commission for FY 2011 and FY 2012 and the percent change in the total number of licenses between these two fiscal years. Of the 40 boards and commissions, 27 reported increases in the number of active licenses and 13 reported decreases. Four boards and commissions reported increases in active licenses of more than 10% and five reported decreases of more than 10%.

Legislation effective in FY 2012

The bills discussed below became effective in FY 2012. H.B. 153, the budget bill of the 129th General Assembly, included provisions that affect multiple boards.

A provision in H.B. 153 affected boards that use the eLicensing system. The eLicensing system electronically tracks and records professional licenses and allows licensees to renew their licenses online. The bill provided funding in the Department of Administrative Services to replace the eLicensing system by allowing the Director of OBM, over the FY 2012-FY 2013 biennium, to transfer up to \$3.0 million from Fund 4K90, Fund 5C60 (used by the Medical Board), and Fund 5HS0 (the Casino Control Operating Fund) to the newly created Ohio Professionals Licensing System Fund (Fund 5JQ0). In FY 2012, \$2.0 million was transferred to Fund 5JQ0: \$1,760,000 from Fund 4K90, \$235,400 from Fund 5C60, and \$4,600 from Fund 5HS0. An additional \$1.0 million may be transferred from these funds in FY 2013.

Counselor, Social Worker, and Marriage and Family Therapist Board

H.B. 153 authorized the Counselor, Social Worker, and Marriage and Family Therapist Board to establish fees for approving continuing education programs and providers, as well as for replacement wall certificates. The Board established the fees as follows: \$125 for continuing education providers, \$30 for continuing education programs, and \$15 for certificates. In FY 2012, these new fees generated about \$12,000 in additional annual revenue: \$6,390 from continuing education programs, \$4,375 from continuing education providers, and \$1,245 from replacement certificates. All Board fee revenue is deposited into Fund 4K90.

Board of Emergency Medical Services

H.B. 128 revised the priorities used by the Board of Emergency Medical Services to distribute grants funded through the Highway Safety Fund (Fund 83P0). The total amount of awards distributed annually ranges from \$2.5 million to \$4.0 million. The bill also allowed an emergency response vehicle to be dispatched with only one emergency medical technician instead of two. The bill also specified additional titles for certain emergency medical service personnel.

State Board of Registration for Professional Engineers and Surveyors

H.B. 153 changed the renewal cycle for individual registrations from annual to biennial. Under the new biennial renewal cycle, there could be significant fluctuations in the amount of revenue received on a year-to-year basis, with the vast majority of revenue coming in even-numbered fiscal years. The State Board of Registration for Professional Engineers and Surveyors expects this change to save approximately \$28,000 over the FY 2012-FY 2013 biennium from lower postage, printing, and credit card transaction costs.

State Medical Board of Ohio

H.B. 153 permitted the State Medical Board to establish procedures for limited practitioners, including massage and cosmetic therapists, to take a national licensure exam instead of one administered by the Board. The bill also provided for a new fee structure for limited practitioners. The bill eliminated both the licensure examination fee of \$250 and the examination of preliminary education fee of \$35 and instead established a single certificate application fee of \$150. In addition, the bill increased the biennial certificate registration fee from \$50 to \$100.

H.B. 292 renamed the visiting medical faculty certificate issued by the State Medical Board as a "clinical research faculty certificate." The bill specified that a clinical research faculty certificate may be renewed for a three-year period and that there is no limit on the number of times a certificate can be renewed. The bill established a \$375 certificate renewal fee, which is the same amount as the initial certificate fee. There were 18 active certificates in FY 2012. The provisions related to the clinical research faculty certificate went into immediate effect late in FY 2012 under an emergency clause in the bill. The other parts of H.B. 292, which mainly dealt with genetic counseling, went into effect in FY 2013.

H.B. 78 required the State Medical Board to revoke a physician's license to practice medicine in Ohio if a physician commits the offense of terminating or attempting to terminate a human pregnancy after viability. It also required the Board to suspend a physician's license to practice medicine in Ohio for a period of not less than six months if the physician commits the offense of failure to perform viability testing.

Motor Vehicle Dealers Licensing Board

H.B. 114 established a new license for Motor Vehicle Construction Equipment Auctions. The fee is \$7,500 and the license is renewable every five years. In FY 2012, the new fee generated \$7,500 in revenue to the Board from the one licensee.

Board of Nursing

S.B. 83 eliminated restrictions on the authority of certain advanced practice nurses (APNs) to prescribe schedule II controlled substances to patients at specified locations. Some of the specified locations include:

- Hospitals registered with the Department of Health;
- Entities owned or controlled by a hospital;
- Health care facilities operated by the Department of Mental Health (DMH) or the Department of Developmental Disabilities;
- Nursing homes licensed by DMH;
- County homes or district homes that participate in Medicare or Medicaid;
- Hospice care programs; and
- Community mental health agencies.

The bill also required an APN applying for a certificate to prescribe to complete a course of study that consists of at least 45 contact hours in pharmacology and related topics, of which at least 36 (instead of 30) must be contact hours of advanced pharmacology training. The course of study in pharmacology and related topics must include training in schedule II controlled substances. The bill also required an APN with prescriptive authority on the bill's effective date to complete at least six contact hours of training on schedule II controlled substances and specified that the APN is subject to the restrictions in current law until the APN receives a new or renewed certificate to prescribe.

State Board of Optometry

H.B. 153 increased various fees and fines collected by the State Board of Optometry as follows:

- The licensure certificate (initial and renewal) from \$110 to \$130;
- The therapeutic pharmaceutical agents certificate (initial and renewal) from \$25 to \$45;
- The topical ocular pharmaceutical agent certificate from \$25 to \$45; and
- The fines for late renewal of a certificate or late completion or submission of continuing education credits from \$75 to \$125.

These increases generated additional revenue of \$95,480 in FY 2012. Board revenues are deposited into Fund 4K90.

State Board of Pharmacy

H.B. 153 increased the registration fee for wholesale distributors of dangerous drugs from \$150 to \$750 for initial registrations and subsequent renewals and also increased the penalty for nontimely renewals of these registrations from \$55 to \$150. In FY 2012, these increases generated an additional \$973,265 in revenue, which was deposited into Fund 4K90. H.B. 153 also made clarifying changes to the law governing the regulation of pain management clinics. These changes are related to the enactment of Am. Sub. H.B. 93 of the 129th General Assembly, which became effective in FY 2011.

State Board of Sanitarian Registration

H.B. 153 increased renewal fees for registered sanitarians and sanitarians-intraining from \$74 to \$80 and also increased the late fee for a renewal application from \$27 to \$50 (the bill specified that this late fee is in addition to the actual renewal fee). Fee changes went into effect in late September 2011. The new fees generated an additional \$5,720 in revenue in FY 2012. Additional revenues in future years may be greater, as the fees will be in effect for an entire year. Board revenues are deposited into Fund 4K90.
