

# 2023 STATISTICS ON CONCEALED-HANDGUN LICENSES IN OHIO

Dear Colleagues,

In June 2022, Ohio became the 23rd state to allow its citizens to carry a concealed handgun without a permit – a right often referred to as constitutional carry. The change did not, however, eliminate the state's permitting system, which continues to benefit gun owners who choose this option.

Specifically, permit-seekers benefit from eight hours of required education that covers handgun safety and includes two hours on a shooting range under the guidance of certified instructors. Additionally, permit-holders can carry their firearms when traveling in states that honor Ohio's concealed-carry license.

Since the revised law took effect, the number of concealed-carry licenses issued by Ohio's 88 county sheriffs has predictably decreased. In 2023, the first full year of constitutional carry, 15,581 new licenses were issued, compared to 94,298 issued in 2021, the last full year that permits were required.

The report that follows, required under Ohio Revised Code Section 109.731(C), provides additional details on concealed-carry licenses and applications for each county in Ohio. The report is based on 2023 data supplied by the Ohio Peace Officer Training Commission, a division of my office. Mayors of several large Ohio cities were concerned that constitutional carry would fuel crime in their communities. In response, the Center for Justice Research, a partnership between my office and Bowling Green State University, conducted a study. Researchers examined gun crime in Ohio's eight largest cities from one year before constitutional carry was enacted until one year after enactment. The study found an overall decline in gun crime in six cites, with rates falling the most in Parma (22%), and Akron, Columbus and Toledo (18% each). Gun crime rates increased in Dayton (6%) and Cincinnati (5%). The takeaway is that while urban crime remains a serious issue, we should focus our attention on violent criminals rather than Ohioans who responsibly exercise their Second Amendment rights.



In 2023, Ohio's sheriffs issued 42% fewer new concealed-carry licenses than they did the previous year.



The number of licenses renewed in 2023 increased nearly 20% over 2022.





The number of licenses suspended in 2023 increased 4% over 2022.



Under Ohio Revised Code Section 2923.128, sheriffs must suspend a concealed-handgun license upon learning that the holder has been arrested or charged with certain offenses, or if the licensee is the subject of a protection order. If the holder is found not guilty or charges are dismissed, the license may be returned. Sheriffs are not required to report a reason for a license suspension.

#### Licenses revoked

The number of licenses revoked in 2023 fell 11% from 2022.



Under ORC 2923.128, sheriffs must permanently revoke the license of any person who no longer meets the eligibility requirements to carry a concealed handgun. A license may be revoked when the holder moves out of state, dies, cancels the license, is convicted of a disqualifying crime, or becomes subject to the law's restrictions on mental illness or drug or alcohol dependence. Sheriffs are not required to report the reason for a revocation.

#### License applications denied

The number of regular-license denials decreased 47% from 2022.

The law requires sheriffs to deny an application to any person who fails to meet the eligibility criteria specified in ORC 2923.125 for regular licenses or ORC 2923.1213 for temporary emergency licenses.

#### Reciprocity agreements

Ohio law gives the attorney general the right to negotiate concealed-carry reciprocity agreements with other states. Under such agreements, Ohio and other states agree to respect each other's concealed-carry laws and recognize each other's permit holders.

Effective March 23, 2015, Ohio recognizes the concealed-handgun license of any non-resident who has a valid concealed-handgun license from any other state, regardless of whether Ohio has entered into a reciprocity agreement with that state. Because of Ohio's recognition of those licenses, the attorney general has confirmed automatic reciprocity for Ohio license holders with several additional states.

Ohio permit holders have reciprocity with 39 states, either by reciprocity agreement or by automatic reciprocity. The 11 states that DO NOT have reciprocity with Ohio are:

- California
- Connecticut
- Hawaii
- Illinois
- Maryland
- Massachusetts

- New Jersey
- New York
- Oregon
- Rhode Island
