During the February 17, 2016, meeting, the Ohio Healthier Buckeye Advisory Council discussed finalizing and releasing the Request for Grant Application (RFGA) for the Healthier Buckeye Grant Pilot Program established by the 131st General Assembly in HB 64.

The Ohio Department of Job and Family Services (ODJFS), with the Healthier Buckeye Advisory Council released a Request for Grant Applications (RFGA) for the purpose of awarding one-time grants to local healthier buckeye councils as established under section 355.02 of the Ohio Revised Code (ORC) to promote the development of self-sufficiency and reduce reliance of low-income individuals and families in the state of Ohio. Local healthier buckeye councils were requested to submit an application identifying a need in their community, barriers to self-sufficiency among a majority of its low-income population, the proposed program, its outcomes and measures, as well as descriptions of the council and its collaborators' experience and capabilities.

Local healthier buckeye councils could request up to \$750,000.00 per application to fund their program; there was no minimum request amount. Councils were to submit up to three (3) applications for separate programs, and identify each application as its first, second or third priority. All first-priority applications were reviewed and qualifying applications were scored by the Application Review Team (ART). Second-and third-priority applications were only to be reviewed and scored based on the availability of funds.

The RFGA was posted on March 3, 2016, and was opened on May 3, 2016. ODJFS received thirty-three (33) "first-priority" applications on behalf of the Council, eleven (11) second-priority applications and three (3) third-priority applications. Twenty-two (22) applications were recommended by the ODJFS staff scoring team to the ODJFS Director, for a total of \$11,385,726.14 in recommended grant awards.
