Submitted to fulfill the reporting requirements of R.C. 4123.446(B); reports that Attucks Asset Management (Attucks) and Leading Edge Investment Advisors (LEIA) (two minority- or women-owned business enterprise [MWBE] manager of manager [MoM] firms) have each overseen the management of \$100 million (which combined, has grown to \$279 million, representing 1.19% of total SIF investment assets) for an active broad All Cap Russell 3000 U.S. equity mandate from April 2, 2012 to present; states that the BWC Board of Directors charged Attucks and LEIA to select MWBEs to manage assets in specified asset classes with the goal of achieving above-benchmark index rates of returns; reports the total BWC MWBE net of fees performance was (+23.50%) versus the Russell 3000 benchmark index of (+25.22%); reports that eight MWBE firms manage BWC assets under Attucks' MoM program and nine MWBE firms manage under LEIA's MoM program, with one being common to each of these MoM programs and three being Ohio-based firms; for a digital copy contact the library 338.6422/Oh3m/2014
