Legal Basis: Section 373.10 of H.B. 49 of the 132nd G.A. (originally established by Controlling Board on February 7, 1994)

Purpose: This line item is used to finance the Ohio Emergency Management Agency's role in: (1) the management and oversight of U.S. Department of Energy sites located in Ohio (coordination and public awareness, emergency planning and exercising, hazardous assessments, and data management), and (2) the oversight of transuranic waste shipments through Ohio. Some of the money is passed through to other participating state agencies such as the Department of Health and the Public Utilities Commission of Ohio.
