The Legislative Service Commission (LSC) has sponsored a legislative internship program for over 50 years. In May 2010, the program was renamed the LSC *Legislative Fellowship Program* from the LSC *Internship Program* to more accurately reflect the educational and professional goals of the program. The recruiting, selecting, training, and assigning of the fellows are responsibilities of the nonpartisan LSC staff. All LSC fellows have at least a bachelor's degree and are full-time employees of the LSC for 13 months.

Traditionally, 23-24 fellows are hired. Six fellows are assigned to the House and Senate majority caucuses and four fellows are assigned to the House and Senate minority caucuses. LSC also assigns two fellows to Ohio Government Telecommunications (OGT)/The Ohio Channel and one or two fellows are retained to work with the LSC research and fiscal staff. Once assigned, each caucus chief of staff (in conjunction with caucus leadership) and supervisors within OGT and the LSC make decisions regarding individual assignments to specific elected officials or to general office responsibilities.

General program administration, including monitoring of assignments, evaluation of performance, and the provision of additional training and educational opportunities, remains with the LSC program staff throughout the program year.
