These funds will be used to continue renovations to this 2,600-seat auditorium which is listed on the National Register of Historic Places and is located in Youngstown, Ohio. Combined with previous state appropriations from Am. Sub. H.B. 790 of the 120th General Assembly for \$600,000 and \$625,000 in state appropriations from Am. Sub. H.B. 850 of the 122nd General Assembly, state appropriations for this project total \$1,725,000.

CAP-033	Woodward Opera House Renovation (Knox)	Renovation/ Replacement	\$250,000

This opera house located in Mt. Vernon is one of the oldest theatres in the United States and was constructed around 1853. It is managed by the Knox County Performing Arts Coalition. This funding is for renovations and upgrades. Combined with \$250,000 in state appropriations for this project from Am. Sub. HB 850 of the 122nd General Assembly, state appropriations for this project total \$500,000.

CAP-037	Canton Palace Theatre Renovations (Stark)	Community Projects	\$750,000

Built in 1926, this 1,514-seat theatre is located in Stark County within the City of Canton. These funds will continue state assistance for upgrades. H.B. 850 of the 122nd General Assembly, with this bill, state funding for this project total \$2,050,000.

The Hayes Presidential Center renovation project continues with an addition to the library, alterations to the museum building, improvements to the exterior structures, and the design and possible installation of a new presidential exhibit. This 25-acre estate is a memorial to the 19th president of the United States, Rutherford B. Hayes, and is the showcase site for the history of Ohio leadership. Past appropriations for improvements to the home included \$3.0 million for planning, roof replacement, replacement of the HVAC system, and asbestos abatement.

CAP-735	Paul Lawrence Dunbar House (Montgomery)	Renovation/ Replacement	\$672,000

These moneys will be used primarily to expand and upgrade the visitor's center at the Paul Lawrence Dunbar State Memorial. This historic site, located in Dayton, was the home of the famous poet. The visitor's center will be upgraded by addition of a classroom and toilet facilities, as well as yard improvements, an upgraded parking lot, and a barn exhibit. These moneys comprise the last phase of improvements to the site. H.B. 850 of the 122nd G.A. provided \$100,000 for the restoration of the barn.

CAP-741	Adena State Memorial (Ross)	Renovation/ Replacement	\$3,888,000

Adena State Memorial showcases the 295-acre historic site and former home of the sixth governor of Ohio, Thomas Worthington. This historic site is located in Chillicothe. Benjamin Latrobe, one of the foremost architects of the time, designed Adena and it remains a reflection of the lifestyle of affluent Ohioans during the early 19th century.

In order to prepare the site for the Ohio bicentennial in 2003, moneys are requested to renovate the mansion by installing new plumbing and electrical systems and new upholstery and draperies. Improvements to the barn include replacing the roof and extermination services. Various outbuildings will be repaired and renovated as well. Another objective of the project is to restore the vermin-infested gardens to the condition that would have been enjoyed by the Worthington family. Other renovations include modifying walks to comply with accessibility laws.

H.B. 790 of the 120th G.A. appropriated \$34,000 for exterior renovation and repairs; H.B. 748 of the 121st G.A. appropriated \$447,338 for architectural services and some repairs; H.B. 850 of the 122nd G.A. appropriated \$350,000 for the renovation and H.B. 283 of the 123rd G.A. appropriated another \$1.2 million. The moneys from the last two appropriations have been used to construct a visitors' center with new sewer and water lines, landscaping, year-round exhibits, and an electronic classroom with audio-visual theater.

CAP-742	Ft. Meigs Museum and Exhibit Improvements (Lucas)	Renovation/ Replacement	\$1,805,000

Located in Perrysburg, Fort Meigs was built in during the War of 1812 to protect northwest Ohio and Indiana from British invasions. The amount requested reflects the costs of renovating and acquiring objects for existing exhibits. The total project includes the construction of a visitors' center and new outdoor exhibits. Funds are requested also to continue the repair and preservation work on the blockhouses and Quartermaster's houses and to create infrastructure to comply with ADA requirements. The Fort Meigs project serves as the Gateway site that focuses on military history in Ohio.

H.B. 850 of the 122nd G.A. appropriated almost \$3.0 million and prior capital bills appropriated at least \$1.6 million for improvements to the site.

CAP-780	Harding's Tomb and Site Renovations (Marion)	Renovation/ Replacement	\$138,000

The Harding Tomb, a monument made of marble, marks the graves of President Harding and his wife. Moneys are needed to secure the marble and make other upgrades to the monument, including landscaping.

CAP-781	Archives/Library Automation (Franklin)	Equipment	\$300,000

These moneys will be used to provide interactive video distance learning programs to schools in Ohio SchoolNet-funded local and regional distance learning consortiums. Equipment will be purchased to create educational videotapes.

Moneys are requested to replace an aging chiller in the Ohio Historical Center, continuing a multi-year plan to renovate the Center. The Ohio Historical Center houses the administration offices of the Society, the state archives, and a museum that highlights the archaeology, and the natural and social history of Ohio. Earlier capital bills provided for more than \$2.8 million for the rehabilitation.

CAP-786	Piqua/Fort Pickawillany Acquisition and Improvements (Miami)	New Construction	\$435,000

Piqua Historical Area State Memorial, located near Piqua, showcases the farm of John Johnston, a federal Indian agent for Ohio during the early 19th century. Fort Pickawillany, which is near the Memorial, is the earliest known site of Indian and European contact in Ohio. This project includes the reconstruction of General Harrison, a replica of a wooden, mule drawn canal boat.

CAP-789	Neil Armstrong Air and Space Museum Improvements (Auglaize)	Renovation/ Replacement	\$200,000

The Neil Armstrong Air and Space Museum chronicles the history of flight through the space program. Moneys will be used to build a new maintenance and storage building, seal the dome of

the museum, and upgrade restrooms for compliance with accessibility laws. Prior capital bills have appropriated just over \$1.0 million for renovations to the museum.

CAP-790	Reese-Peters Site Improvements (Fairfield)	Community Projects	\$250,000

This project involves restoring and rehabilitating the main residence as an arts museum and cultural center. Located in Fairfield County and built in 1834, the house is considered to be an outstanding example of Greek Revival architecture.

These moneys will be used to replace outdated and unreliable fire and security systems at various key museums and historic sites, as well as the Ohio Historical Center. H.B. 850 appropriated \$100,000 to replace part of the fire alarm system in the Center.

This item will remove and replace underground fuel storage tanks at Fort Ancient State Memorial in Warren County, Piqua Historical Area in Miami County, and the Ohio Historical Center in Franklin County. These sites have the Society's only remaining tanks that do not meet U.S. EPA criteria.

Operating moneys from the H.B. 283 will be used in FY 2000 to replace the HVAC system at the site.

\$450,000 for the records retrieval automation; H.B. 790 of the 120th appropriated \$309,360 and H.B. 748 of the 121st added another \$1,500,000.
