WILDLIFE FUND (7015)

C725B0 Access Development **\$13,600,000**

County: Multi-county - Statewide, Ottawa

DNR plans to use funding under this appropriation for two purposes. First, DNR plans to use \$12.6 million for the acquisition of 6,000 acres of reclamation land from American Electric Power Inc. (AEP). The property is part of AEP's ReCreation Lands which consist of approximately 100,000 acres of reclamation land that, since 1948, has been open to the public for recreational use under an agreement with DNR's Division of Wildlife. AEP has begun divesting portions of the ReCreation Lands and is planning for further divestiture of the property. DNR plans to obtain the remaining 60,000 acres over time, with this initial purchase consisting of 6,000 acres, followed by additional acquisitions of 3,000 acres per year.

In addition to the land acquisition, DNR plans to use \$1.0 million to replace two bridges that provide access to the Lake Erie beach site at Crane Creek Wildlife Area in Ottawa County.

C725K9 Wildlife Area Building Development/Renovations **\$8,150,000**

County: Multi-county - Greene, Lucas, Mahoning, Ottawa, Portage

This appropriation will support repairs and upgrades at wildlife areas in Ottawa, Lucas, Greene, Mahoning, and Portage Counties. Of the \$8.15 million provided by the bill, DNR will use \$4.9 million (60.1%) to repair a levee separating Lake Erie from coastal wetlands located at Magee Marsh Wildlife Area that was damaged during severe storms in CY 2015. DNR plans to use \$3.0 million (36.8%) at Spring Valley Wildlife Area for improvements to the shooting range including creating a new entrance, range building, and education center, addressing drainage issues, and reclaiming lead from the shooting field and backstops. Finally, DNR plans to use the remaining \$250,000 (3.1%) to improve archery ranges at Lake Milton State Park and Berlin Wildlife Area.

C725W0 MARCS Equipment **\$1,866,087**

County: Statewide

This funding will be used to replace outdated voice and data equipment used by wildlife law enforcement to communicate over the Multi-Agency Radio Communications System (MARCS). The current radios and data terminals are outdated and will no longer be serviceable through their manufacturer.

ADMINISTRATIVE BUILDING FUND (7026)

C725D7 MARCS Equipment \$5,996,598
County: Statewide

This funding will be used to replace outdated voice and data equipment used by DNR law enforcement officers to communicate over the Multi-Agency Radio Communications System (MARCS). The current radios and data terminals are outdated and will no longer be serviceable through their manufacturer.

C725N7 District Office Renovations \$3,000,000
County: Harrison

This funding will support the construction of a new mine safety training facility in Harrison County. The facility will include administrative offices, classrooms, a mine scenario training facility, team competition fields, and mine fire training simulator, hose pad, and an area mine rescue station. H.B 497 of the 130th G.A., the capital appropriations bill for the FY 2015-FY2016 capital biennium, provided \$2.0 million for the facility assessment and master planning for the new facility.

OHIO PARKS & NATURAL RESOURCES FUND (7031)

C72512 Land Acquisition \$475,000
County: Statewide

This appropriation will be used by DNR to acquire property in order to improve access to DNR owned dams across the state. Many of DNR's dams are surrounded by private property, making access to the dams for maintenance activities difficult.

C72549 DNR Facilities Development \$1,500,000
County: Statewide

Of this line item, \$750,000 will be used on an as-needed basis for the design and construction of projects associated with declared emergency or public exigency situations. The remaining \$750,000 will be used to retain professional services consulting firms to conduct site investigations, perform preliminary and final design, prepare construction documents, secure regulatory permits, and oversee construction for small-scale capital improvement projects at DNR facilities.

C725E1 Local Parks Projects Statewide \$5,108,985

County: Statewide

This appropriation will be used to support grants for local recreation projects through the NatureWorks Program. Under current law, 20% of the amount appropriated from the Ohio Parks and Natural Resources Fund (Fund 7031) for each capital biennium is to be allocated to the program.

C725E5 Project Planning \$1,100,938

County: Statewide

This line item is used to reimburse eligible DNR staff expenses associated with the design and construction of capital improvement projects or land acquisition activities paid for from the Ohio Parks and Natural Resources Fund (Fund 7031). Specifically, this line item is used to transfer funds to the Capital Expenses Fund (Fund 4S90), which is within DNR's operating budget, in order to cover the eligible payroll and administrative cost reimbursements.

C725K0 State Park Renovations/Upgrading \$11,060,000

County: Statewide

This line item will be used to support a variety of projects including electrical and telecommunications infrastructure improvements, construction of shelter houses and play structures, trail maintenance, bridge replacement, and environmental remediation projects at state parks and DNR day use facilities statewide. Additionally, funding under this line item will be used to complete urgent or emergency projects at DNR capital facilities to correct hazards posing immediate safety risks.

C725M0 Dam Rehabilitation \$2,550,000

County: Statewide

This line item will be used to complete a comprehensive assessment of 59 dams owned by DNR and to perform, on an as needed basis, remedial improvements to make the comprehensive assessments possible. Additionally, this line item will be used for a variety of rehabilitation projects already identified as necessary, including embankment stability and spillway and lake drain repairs at several dams across the state.

C725N5 Wastewater/Water Systems Upgrades \$2,750,000

County: Statewide

This line item will be used for the design and construction of projects to correct deficiencies in DNR-managed water treatment, distribution, and wastewater systems and bring them into compliance with current regulatory requirements.

C725N8 Operations Facilities Development \$1,000,000

County: Statewide

These funds are to be used for the design and construction of various building and site renovation projects, primarily at state forest facilities, as well as for the purchase of upgraded and replacement Division of Forestry wildfire safety equipment.

PARKS & RECREATION IMPROVEMENT FUND (7035)

C725A0 State Parks, Campgrounds, Lodges, Cabins \$23,910,514

County: Statewide

This line item will be used for the evaluation, design, and construction of projects to improve campground, lodge, and cottage facilities at Ohio's 74 state parks. These may include basic renovations such as utility upgrades, roofs, restrooms, room renovations and ADA compliance upgrades, and other such work.

C725B5 Buckeye Lake Dam Rehabilitation \$61,546,960

County: Multi-county - Fairfield, Licking

This line item will be used to support a comprehensive risk reduction measure necessary at Buckeye Lake Dam, a 4.1 mile long earthen embankment in Fairfield and Licking Counties. Currently, interim risk reduction measures are underway to reduce the potential of dam failure. Funding for the FY 2017-FY 2018 capital biennium will be used to correct uncontrolled seepage, sheet pile and masonry deterioration, and to bring the dam into compliance with Ohio dam safety laws and rules.

C725C4 Muskingum River Lock and Dam \$3,750,000

County: Washington

This line item will support the assessment and rehabilitation of locks and dams along the Muskingum River in Muskingum, Morgan, and Washington Counties. In particular, this funding will be used to help bring Lock and Dams No. 2 through No.11 into compliance with Ohio dam safety laws and rules while protecting the historic value of these structures that were constructed in the 1840's.

C725E6 Project Planning **\$6,070,285**

County: Statewide

This line item is used to reimburse eligible DNR staff expenses associated with the design and construction of capital improvement projects or land acquisition activities paid for from the Parks and Recreation Improvement Fund (Fund 7035). Specifically, this line item is used to transfer funds to the Parks Capital Expenses Fund (Fund 2270), which is within DNR's operating budget, in order to cover the eligible payroll and administrative cost reimbursements.

C725R4 Dam Rehabilitation - Parks **\$55,425,000**

County: Statewide

This line item will be used for design and construction work on projects to correct deficiencies at DNR-owned dams and other water control structures, bringing them into compliance with current dam safety regulations. DNR is responsible for 117 regulated dams statewide, 56 of which are rated as Class I, which have the potential for loss of life and significant property damage in the event of failure.

C725R5 Lake White State Park - Dam Rehabilitation **\$27,376,761**

County: Pike

This line item will be used to reimburse the Ohio Department of Transportation (ODOT) for Phase II of the Lake White Dam Improvement Project. ODOT is serving as the lead for design and construction involving armoring the downstream side of the dam, constructing a new lake drain system, and reconstructing the State Route 104 roadway and bridge along the top of the dam.

C725U4 Water Quality Equipment and Projects **\$7,400,000**

County: Statewide

CLEAN OHIO TRAIL FUND (7061)

C72514 Clean Ohio Trail Fund **\$12,500,000**

County: Statewide

These funds will support the continuation of competitive grants to local governments and other eligible entities through the Clean Ohio Trail Fund (Fund 7061). These grants provide funding for recreational trail projects throughout the state.

WATERWAYS SAFETY FUND (7086)

C725A7 Cooperative Funding for Boating Facilities \$16,750,000

County: Statewide

This appropriation will support competitive grants of up to 100% of the cost for renovation and development of boat launch ramps, marinas, and dredging at public recreational boating areas statewide. Grants may be awarded both to eligible outside entities such as local governments, as well as other DNR divisions, primarily the Division of Parks and Recreation.

C725N9 Operations Facilities Development \$2,300,000

County: Statewide

This line item will be used to provide for the design and construction of capital improvement projects at Division of Watercraft facilities throughout the state. These may include the repair and replacement of patrol boat storage facilities and district office renovations.

C725Z0 MARCS Equipment \$1,511,165

County: Statewide

This funding will be used to replace outdated voice and data equipment used by watercraft law enforcement to communicate over the Multi-Agency Radio Communications System (MARCS). The current radios and data terminals are outdated and will no longer be serviceable through their manufacturer.
