Legal Basis: ORC 2743.48

Purpose: The revenue is used to pay a sum of money to those who have been judged wrongfully imprisoned, in addition to reasonable attorney fees and other expenses. When a wrongful imprisonment judgment is journalized, the Controlling Board, upon certification by the Court of Claims, appropriates and transfers the sum necessary to this special account. Since the Controlling Board provides money for the awards on an as-needed basis, no appropriations are provided in the main appropriations act of the General Assembly.

Legal Basis: ORC 2743.191 (originally established by Am. Sub. H.B. 82 of the 111th G.A.)

Purpose: The revenue deposited in this fund is used for the purpose of compensating victims of crime, including all administrative costs incurred by the Court and the Attorney General’s office. Revenue for various victims assistance programs are also drawn from the fund and are appropriated in both the budgets of the Court of Claims and the Attorney General. The amounts paid against claims awarded to victims are determined by commissioners of the Court of Claims, but the size of any award cannot exceed \$50,000 per victim per any one incident.
