LSC Budget Spreadsheet: Executive to House Passed Comparison

May 7, 2003

Note: The estimated General Revenue Fund (GRF) spending for FY 2003 used in this LSC Redbook reflects the 2.5% reduction made as a result of the Governor's January 22, 2003 budget cut order. The executive reduction was applied across-the-board to FY 2003 GRF appropriations, subject to certain exceptions. Subsequent to such reductions (and not reflected in the Redbook), state agencies were permitted to reallocate the amount that each of their GRF appropriation line items was reduced, while still absorbing the 2.5% budget cut within the total amount of their GRF appropriations.

OVERVIEW

The State Board of Sanitarian Registration was created in 1977 to ensure sanitarians in the field of environmental health possess and maintain specialized knowledge and skills that pertain to the field of environmental health science. Environmental health is an aspect of public health that deals with the following topics: air quality, food quality and protection, hazardous and toxic substances, consumer product safety, housing, institutional health and safety, community noise control, radiation protection, recreational facilities, solid and liquid waste management, vector control, drinking water quality, milk sanitation, and rabies control.

About 80% of the Board's licensees are government employees who must be licensed per government mandate. Most of these government employees work for city or county health departments. The Board currently licenses approximately 1,500 people. The Board renews its licenses annually. In FY 2002 the Board had revenues and expenditures of \$112,388 and \$109,341 respectively. The Board contributed \$3,047 more to Fund 4K9 than it was appropriated for the last renewal cycle.

The executive recommended budget for the Board is \$124,892 for FY 2004 and \$125,612 for FY 2005. The Board requested fee increases to generate revenue to pay for the additional costs resulting from payroll inflation in the upcoming biennium. The fee increases are expected to generate approximate annual revenues of \$131,945 in FY 2004 and \$134,246 in FY 2005.

ANALYSIS OF EXECUTIVE PROPOSAL

Purpose: License and regulate sanitarians in the field of environmental health

The following table shows the line items that are used to fund this program series, as well as the Governor's recommended funding levels.

Program Description: In accordance with Chapter 4736. of the Revised Code, the State Board of Sanitarian Registration protects the public health by ensuring that individuals who engage in the practice of environmental health possess and maintain specialized knowledge and skills that pertain to the field of environmental health science.

Funding Source: General Services Fund Group (Fund 4K9). Currently, all revenue from the 24 occupational licensing boards is placed in Fund 4K9 and then reallocated to each board. Each board must raise enough revenue through its license fees to cover its expenses.

Line Items: 893-609, Operating

Implication of Recommendation: The Executive has recommended an 8.5% increase in funding for FY 2004 and a 0.58% increase for FY 2005. The increase in funding will be supported from proposed fee increases of 13% for renewals and 32% for applications. According to the Board, the fee increases are necessary to cover its operating costs including the continued use of an intermittent clerical position and technical support. The technical support was previously provided at no cost by other state agencies.

The Board also has one intermittent clerk who works approximately 600 hours per year. The Board's executive director performs all investigations. The Board has scheduled seven board meetings for each year. The Board members are only reimbursed their travel expenses.

PERMANENT AND TEMPORARY LAW

This section describes permanent and temporary law provisions contained in the executive budget that will affect the Board's activities and spending decisions during the next biennium.

Permanent Law Provisions

Fees; fees for initial and renewal licenses (R.C. section 4736.12)

Under this provision, sanitarians would be required to pay additional application and renewal fees. The revenue generated would allow the Board to cover operating expenses and indirect costs. The fee increases listed below would generate about \$132,000 of revenue annually.

Subject: Fees for Initial and Renewal Licenses**R.C. 4736.12**

Increases the fee to apply for registration as a sanitarian-in-training or as a sanitarian if already a sanitarian-in-training from \$57 to \$75. Increases the fee for all others to apply for registration as a sanitarian from \$114 to \$150.

Removes the existing requirement that the renewal fee for registered sanitarians and sanitarians-in-training be fixed by the Board of Sanitarian Registration at not more than \$61 and replaces it with a renewal fee of \$69.

Fiscal effect: The proposed fees would generate about \$132,000 of revenue to be deposited in the Occupational Licensing and Regulatory Fund (Fund 4K9).
