Veterans' Organizations

- The total funding for all organizations is \$2,809,238 for the FY 2006-2007 biennium
- The Rainbow Division Veterans' Association and the Veterans of World War I requested no funding for the biennium

OVERVIEW

The state of Ohio currently grants subsidies to 13 different organizations that serve Ohio's veterans. The primary mission of all of these organizations is to promote and provide assistance to veterans in Ohio. These groups educate veterans and their dependents on the various benefits available to them. Some of the organizations provide emergency assistance. All of the various veterans' organizations promote the remembrance of their fellow veterans and the wars in which they fought.

All 13 veterans' organizations receive a GRF subsidy. In addition to state funding, each organization provides much of its own funding through federal grants, membership dues, fundraising efforts, and private donations.

Recommended Funding FYs 2006-2007

The proposed funding for the Veterans' Organizations is flat-funded at estimated FY 2005 spending levels: \$1,404,619 in FY 2006 and FY 2007, respectively. However, the Both the Rainbow Division Veterans' Association and Veterans' of World War I requested no funding for the FY 2006-2007 biennium.

ANALYSIS OF EXECUTIVE PROPOSAL

Veterans' Organizations

Purpose: This program series provides a subsidy payment to each of 13 veterans' groups to support the needs of their memberships.

The following table shows the line items that are used to fund the Veterans' Organizations, as well as the Governor's recommended funding levels.

Veterans' Organizations Subsidy

Program Description: This program supports the activities of the 13 veterans' groups. Activities of these groups include assisting veterans in the benefits claiming process, transporting veterans to VA medical facilities, assisting veterans with job placement and training, and helping homeless and needy veterans find the assistance they need.

Funding Source: GRF

Line Items: The table above lists all of the line items and groups that are funded.

Implication of Executive Recommendation: Each of the veterans' organizations received the same level of funding as was received in FY 2005. As is indicated in the "Requests Not Funded" section, this level of funding is slightly less than what was requested by three organizations.

Temporary and Permanent Law Provisions:

Release of Funds (Section 212.27). This provision allows for the Veterans' Organizations' line items to be released upon approval by the Director of Budget and Management.

Central Ohio United Services Organization (Section 212.27). This provision earmarks \$50,000 each fiscal year from the appropriation line item 751-501 Vietnam Veterans of America, to be used to support the activities of the Central Ohio USO.

Veterans Service Commission Education (Section 212.27). This provision earmarks \$20,000 in each fiscal year in appropriation line item 753-501, AMVETS, to be used to provide moneys to the Association of County Veterans Service Commissioners to reimburse its member county veterans service commissions for costs incurred in carrying out educational and outreach duties. The Director of Budget and Management shall release these funds upon the presentation of an itemized receipt from the Association for reasonable and appropriate expenses incurred while performing these duties. The Association shall establish uniform procedures for reimbursing member commissions.

REQUESTS NOT FUNDED

There are 13 veterans' organizations that receive a GRF subsidy. Of that number three have requested additional funding above that amount issued in the executive recommendation.

Army and Navy Union

The first request not funded is 746-501, Army and Navy Union. This organization submitted a list of estimated costs for the upcoming biennium. The executive funding level falls \$788 short of what this organization anticipates to be its costs in both FY 2006 and FY 2007. This organization will need to reduce various costs throughout the biennium in order to provide services within the funding level provided.

Military Order of the Purple Heart

The second request not funded is 750-501, Military Order of the Purple Heart. This organization requested a funding increase to increase its communications through a more regular newsletter that updates veterans on their rights and benefits. The current funding level will allow the organization to continue providing the same level of services to veterans.

Marine Corps League

The final request not funded is 756-501, Marine Corps League. The Marine Corps League indicates that it has not had an increase in funding since FY 2000. The organization notes that previous budget cuts have been absorbed by reducing work hours in two service offices. The League indicates that service levels have been maintained despite these cuts.
