Topic	Am. S.B. 84 As Passed by the Senate	Sub. S.B. 84 As Reported by H. Education
Appointment	<p>Requires the Governor to select the Ohio Poet Laureate from the list of nominees compiled by the Ohio Arts Council from nominations submitted by organizations or individuals. (R.C. 3379.12(C)(3).)</p> <p>No provision.</p> <p>Requires the Governor to select the Poet Laureate not later than 120 days after the bill's effective date. (R.C. 3379.12(C)(3).)</p>	<p>Requires the Governor to select the Ohio Poet Laureate from a list of not less than three nominees recommended by the Arts Council based on qualification guidelines established by the Arts Council. (R.C. 3379.12(A).)</p> <p>Requires the Arts Council to submit recommendations for Ohio Poet Laureate to the Governor not less than 90 days prior to the beginning of the Ohio Poet Laureate's term. (R.C. 3379.12(A).)</p> <p>Specifies that the Poet Laureate's initial term of office begins on January 1, 2016. (R.C. 3379.12(B).)</p>
Term of office	<p>Establishes a four-year term of office for the Poet Laureate. (R.C. 3379.12(C)(1).)</p>	<p>Establishes a two-year term of office. (R.C. 3379.12(B).)</p>
Duties	<p>Specifies the duties of the Poet Laureate. (R.C. 3379.12(B).)</p>	<p>No provision.</p>

Qualifications	Specifies qualifications for Ohio Poet Laureate. (R.C. 3379.12(D).)	Requires the Arts Council to establish guidelines for the qualifications of the Ohio Poet Laureate. (R.C. 3379.03(F).)
Nomination	<p>Requires the Arts Council to establish guidelines for the nomination of Ohio Poet Laureate. (R.C. 3379.03(F).)</p> <p>Permits an organization or individual to submit a nomination of an individual for the position of Ohio Poet Laureate to the Arts Council. (R.C. 3379.12(C)(2).)</p>	<p>Requires the Arts Council to establish guidelines for qualifications of Poet Laureate and recommend not less than three candidates, selected based on those qualifications, to the Governor. (R.C. 3379.03(F) and 3379.12(A).)</p> <p>No provision.</p>
Vacancy	<p>In the case of a vacancy during an unexpired term, requires the Arts Council to request nominations to fill the vacancy. (R.C. 3379.12(E).)</p> <p>Specifically requires the Governor to select from the list of nominations a new Ohio Poet Laureate to serve the remainder of that unexpired term. (R.C. 3379.12(E).)</p>	<p>In the case of a vacancy during an unexpired term, requires the Ohio Arts Council to recommend a candidate to serve the remainder of the unexpired term to the Governor, not later than 60 days after the vacancy occurs. (R.C. 3379.12(C).)</p> <p>No provision.</p>
