		Fiscal effect: Any disability benefits forfeited under the bill would reduce the respective retirement system or plan's liability, thus creating a minimal decrease in the retirement system or plan's expenditures to provide such a benefit. For counties and municipalities, the bill may minimally increase administrative costs for holding the required court hearing.
