### **OVERVIEW**

## Law Repealed; Commission Abolished

The enacted budget provides no funding for the Commission on Dispute Resolution and Conflict Management's operating expenses, and repeals its statutory authority. As a result, the Commission will cease all operations, including the delivery of services and activities to schools, courts and communities, and state and local governments.

Prior law created the Commission on Dispute Resolution and Conflict Management to provide Ohioans with constructive, nonviolent forums, processes, and techniques for resolving disputes. The Commission fulfilled that duty by providing dispute resolution and conflict management training, facilitation and mediation services, consultation, and technical program assistance. The Commission was guided by 12 volunteer commissioners, and at the time of its abolition, staffed by the equivalent of three full-time positions.

## **Appropriation Overview**

As noted in Table 1 below, the enacted budget, reflecting the Commission's abolition, does not include any funding in either of FYs 2012 or 2013.
