OVERVIEW

Agency Overview

The budget establishes the ten-member Joint Education Oversight Committee (JEO), a joint committee of the General Assembly, to review and evaluate education programs at school districts, other public schools (i.e., community schools, STEM schools, college-preparatory boarding schools, and the schools for the blind and deaf), and state institutions of higher education that receive state financial assistance in any form. JEO may assess the uses schools and institutions make of state money they receive and determine the extent to which the money improves the school or institution; determine whether an education program meets its intended goals, has adequate operating or administrative procedures and fiscal controls, and is efficiently managed; and examine pilot programs developed and initiated in schools and institutions to determine whether the programs suggest innovative, effective ways to deal with problems that may exist in other schools and institutions and the fiscal impact of adopting the programs throughout the state. JEO may also review bills and resolutions regarding education that are introduced or offered by the General Assembly. JEO is required to submit a report of its findings or results to the General Assembly.

JEO consists of five members of the House of Representatives and five members of the Senate. It is authorized to employ professional, technical, and clerical employees to assist in its work and duties.

The budget authorizes JEO to certify to the Director of Budget and Management the amount of the unexpended, unencumbered balance of 047321 at the end of FY 2016 to be reappropriated to FY 2017 and reappropriates the certified amount.
