

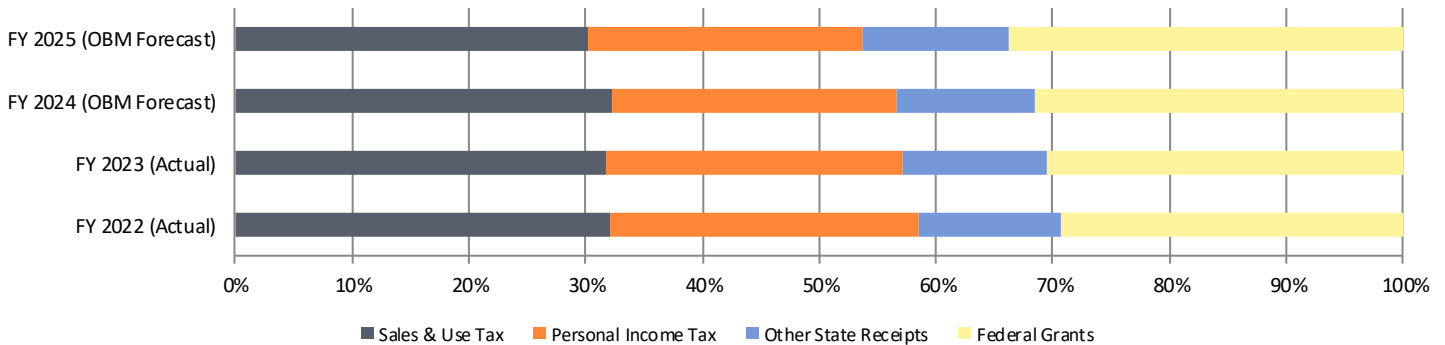

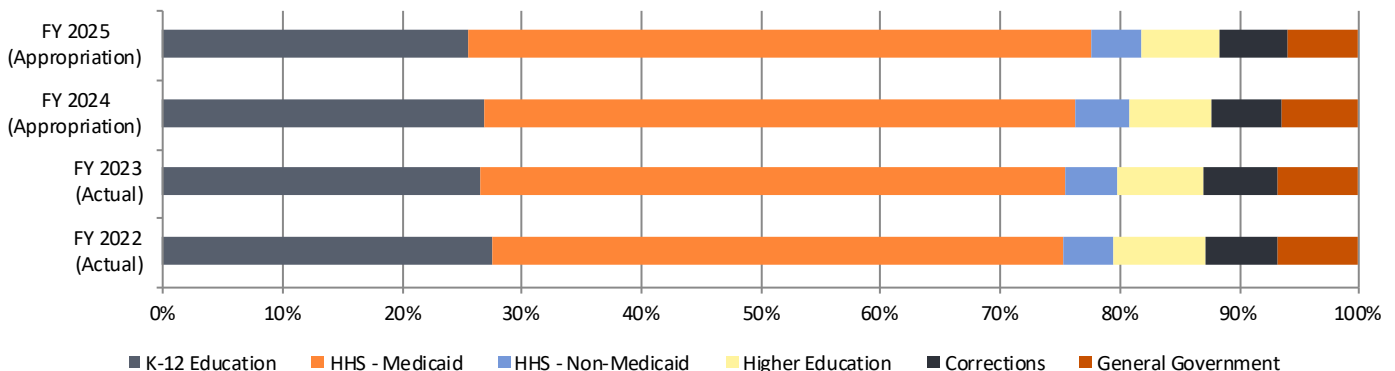

H.B. 33, as enacted, provides state and federal GRF appropriations totaling \$41.42 billion for FY 2024 and \$44.74 billion for FY 2025, increases of 9.7% and 8.0%, respectively. Medicaid (50.8%) and K-12 Education (26.3%) together make up 77.1% of the biennial total. State-source GRF appropriations total \$27.90 billion in FY 2024 and \$29.46 billion in FY 2025, increases of 12.8% and 5.6%, respectively. K-12 Education and Medicaid represent 39.5% and 26.1%, respectively, of the biennial total. In addition to GRF appropriations, H.B. 33 transfers \$6.46 billion in FY 2024 and \$1.57 billion in FY 2025 from the GRF to nonGRF funds. The bill also appropriates \$445.0 million in FY 2024 from the state's remaining allocation from the federal State Fiscal Recovery Fund (ARPA). Across all funds, appropriations total \$95.00 billion in FY 2024, an increase of 8.6%, and \$95.70 billion in FY 2025, an increase of 0.7%.

Medicaid, Health, and Other Human Services

- Across all agencies and funds, appropriations for Medicaid total \$40.81 billion in FY 2024 and \$44.53 billion in FY 2025, increases of 13.0% and 9.1%. The federal share is expected to be 69.4% over the biennium. The GRF portion is \$20.47 billion (50.2%) in FY 2024 and \$23.32 billion (52.4%) in FY 2025.
- The state share of GRF Medicaid appropriations is \$6.96 billion in FY 2024 and \$8.03 billion in FY 2025, increases of 26.8% and 15.5%. The 6.2 percentage point enhancement in the federal reimbursement rate in place during the pandemic will be completely phased-out by the end of December 2023, midway through FY 2024.
- H.B. 33 includes provisions that increase funding to nursing facilities.
- H.B. 33 establishes a new Department of Children and Youth (DCY) to consolidate early childhood programs. GRF appropriations for the new agency total \$753.4 million in FY 2024 and \$761.8 million in FY 2025.
- DCY's GRF-backed appropriations include: \$145.0 million in FY 2024 and \$155.0 million in FY 2025 for the state child protection allocation to public children service agencies; \$130.3 million in each fiscal year for early childhood education, an increase of \$66.3 million (103.5%) over FY 2023; \$93.6 million in each fiscal year as state match for publicly funded child care, an increase of 12.4% over FY 2023; \$46.5 million in FY 2024 and \$55.0 million in FY 2025 for Help Me Grow, increases of 6.7% and 18.3%; \$15.0 million in each fiscal year of new funding for child care infrastructure grants; and \$3.0 million in FY 2024 and \$4.0 million in FY 2025 for early childhood mental health, increases of 164.4% and 33.3%.
- H.B. 33 appropriates \$303.0 million in FY 2024 and \$325.0 million in FY 2025, increases of 12.4% and 7.3% from the GRF for the state's psychiatric hospitals and transfers \$20.7 million in FY 2024 and \$25.8 million in FY 2025 from the GRF for the 988 Suicide and Crisis Lifeline.

K-12 Education

- H.B. 33 continues to phase in the school funding formula enacted in H.B. 110 of the 134th General Assembly at 50% in FY 2024 and almost 67% in FY 2025, with some modifications to the computation. It also updates the formula's cost data from FY 2018 to FY 2022. The bill appropriates \$10.60 billion in FY 2024 and \$10.99 billion in FY 2025, increases of 12.7% and 3.7%, for formula funding to school districts, joint vocational school districts (technical centers), community and STEM schools, and participating chartered nonpublic schools through the state's various scholarship programs. These appropriations are funded through a combination of GRF, including a transfer from the GRF to the Foundation Funding – All Students Fund of \$600.0 million in each fiscal year, lottery profits, and sports gaming revenue. H.B. 33 increases eligibility for the expansion EdChoice scholarship to all families regardless of income, paying 100% of the scholarship to families with incomes up to 450% of the federal poverty level, and phasing down the percentage paid to families with incomes above that amount.
- H.B. 33 appropriates \$1.21 billion in FY 2024 and \$1.22 billion in FY 2025 for property tax rollbacks and the homestead exemption for school districts.
- H.B. 33 appropriates \$136.5 million in each fiscal year from lottery profits, an increase of \$82.5 million over FY 2023, to make payments to community schools and independent STEM schools that meet certain quality standards, increasing the annual per pupil amount compared to FY 2023 from \$1,750 to \$3,000 for economically-disadvantaged students, and from \$1,000 to \$2,250 for all other students. H.B. 33 also appropriates \$87.1 million in FY 2024 and \$88.6 million in FY 2025, increases of 107.3% and 1.7% for community school facilities, increasing the annual per pupil amount for brick and mortar schools from \$500 to \$1,000 compared to FY 2023.
- GRF-supported funding for the Department of Education and Workforce includes \$43.0 million in each fiscal year to reimburse public schools for stipends to teachers to complete professional development in reading; \$64.0 million in FY 2024 to subsidize the cost for public schools to purchase curricula and materials for English language arts and reading intervention; \$6.0 million in FY 2024 and \$12.0 million in FY 2025 for literacy coaches; \$3.0 million in each fiscal year to support teacher credentialing to teach College Credit Plus (CCP) courses; and \$1.5 million in FY 2024 and \$3.5 million in FY 2025 for grants to schools offering new CCP courses.
- H.B. 33 appropriates \$200.0 million in ARPA funding in FY 2024 to the Facilities Construction Commission to assist with facilities construction projects that establish or expand career-technical education programs.

Higher Education

- The state share of instruction (SSI) is funded at \$2.10 billion in FY 2024 and \$2.12 billion in FY 2025, increases of 1.2% and 1.1%. H.B. 33 prohibits increases in instructional and general fees over the biennium for state universities and limits increases to \$5 per credit hour per year for community colleges.
- H.B. 33 appropriates \$200.0 million in each fiscal year for OCOG, Ohio's needs-based financial aid program, an increase of 77.9% over FY 2023.
- New GRF-supported funding for the Department of Higher Education includes: \$100.0 million in FY 2024 for Super RAPIDS projects that strengthen education and training for workforce development; \$10.0 million in each fiscal year for both the Ohio Work Ready Grant and the Talent Ready Grant, programs to assist students pursuing a work credential; \$10.0 million in each fiscal year to support behavioral health at higher education institutions; \$20.0 million in FY 2025 to provide scholarships under the new Governor's Merit Scholarship; \$5.0 million in FY 2024 and \$10.0 million in FY 2025 to provide scholarships to certain individuals who commit to teaching in a qualifying school for at least four years after graduating from a teacher training program; and \$4.0 million in each fiscal year to award grants under the new Teach CS Grant Program.

Economic Development

- H.B. 33 transfers \$700.0 million cash from the GRF to the One Time Strategic Community Investments Fund for future projects.
- H.B. 33 transfers \$667.0 million cash from the GRF to the All Ohio Future Fund and appropriates \$40.0 million in FY 2024 to support economic development throughout the state.
- The budget also provides additional GRF-backed funding to the Department of Development for community improvement, including \$175.0 million in each fiscal year for brownfield remediation, \$150.0 million in FY 2024 for building demolition and site revitalization, \$124.0 million in FY 2024 for water and sewer quality projects, and \$50.0 million in each fiscal year for the new Welcome Home Ohio Program to provide grants and tax credits to assist in rehabilitation and construction of residential property for income-restricted residents.
- Additionally, for the Department of Development, the budget appropriates \$50.0 million in FY 2024 for broadband pole replacement and undergrounding; \$125.0 million in FY 2024 for innovation hubs; and \$25.2 million in each fiscal year for the TechCred Program to support working adults in obtaining technology-focused credentials.

Local Government and Other Initiatives

- H.B. 33 increases the percentage of GRF tax revenue going to the Local Government Fund and the Public Library Fund in codified law from 1.66% to 1.70%, which is expected to provide \$505.0 million in FY 2024 and \$530.0 million in FY 2025 for each fund.
- H.B. 33 transfers \$500.0 million cash from the GRF to the Connect4Ohio Fund (Fund 5ZRO) in FY 2024 and appropriates that amount for the Department of Transportation to expand and improve highways in rural counties.
- H.B. 33 transfers \$270.0 million cash from the GRF to the H2Ohio Fund and appropriates \$60.7 million in FY 2024 and \$60.8 million FY 2025 for the Department of Agriculture, \$46.6 million in each fiscal year for the Department of Natural Resources, \$27.5 million in each fiscal year for the Environmental Protection Agency, and \$132,000 in each fiscal year for the Lake Erie Commission.
- H.B. 33 transfers \$65.0 million cash from the GRF to the Veterans Homes Modernization Fund and appropriates that amount in FY 2024 to the Department of Veterans Services.
- H.B. 33 appropriates \$1.32 billion in FY 2024 and \$1.40 billion in FY 2025 for the operation of Ohio's prisons, increases of 3.9% and 6.0%.
- H.B. 33 transfers \$75.0 million cash from the GRF to the Local Jails Grants Fund and appropriates that amount in FY 2024 to the Department of Rehabilitation and Correction to make grants for local jail facilities.
- H.B. 33 appropriates \$40.0 million in each fiscal year from the GRF for law enforcement training and new GRF-backed funding for the Attorney General of \$6.5 million in FY 2024 for cyber security and technology upgrades; \$750,000 in each fiscal year for the Cyber Crime Division Expansion; and \$1.3 million in FY 2024 for the Ohio Law Enforcement Gateway (OHLEG).
- H.B. 33 appropriates new GRF-backed funding of \$28.2 million in FY 2024 and \$17.8 million in FY 2025 for Next Generation 911; \$13.1 million in each fiscal year for the Ohio Narcotics Intelligence Center; and \$2.5 million in each fiscal year for eWarrant Local Integration.
- H.B. 33 appropriates \$166.1 million in FY 2024 and \$171.9 million in FY 2025 from the GRF for reimbursements to counties for indigent defense, increases of 21.5% and 3.5%.
- H.B. 33 appropriates from the GRF \$15.3 million in each fiscal year to rape crisis centers; \$10.0 million in each fiscal year to domestic violence programs; and \$9.0 million in FY 2024 and \$7.0 million in FY 2025 for the Crime Victim Compensation Program.
