- ➤ The Ohio Department of Mental Health and Addiction Services (OhioMHAS) oversees a statewide network of care that consists of local behavioral health boards, six regional psychiatric hospitals, and numerous community-based provider agencies.
- ➤ The budget provides \$30.0 million in FY 2024 to create the State of Ohio Action for Resiliency Network and a strategic research agenda.
- ➤ The budget provides \$20.7 million in FY 2024 and \$25.8 million in FY 2025 for the 988 Suicide and Crisis Response Lifeline.
- Total budget: \$1.21 billion for FY 2024 and \$1.15 billion for FY 2025.
  - Sources of the budget: GRF (50.4%), Federal (25.4%), and state non-GRF (24.2%).

## **Overview**

## **Agency overview**

The Ohio Department of Mental Health and Addiction Services (OhioMHAS) is responsible for providing statewide leadership for mental health, addiction, and gambling prevention, treatment, and recovery support. In addition, OhioMHAS operates six regional psychiatric hospitals.

OhioMHAS oversees a statewide mental health and alcohol and drug addiction service system that consists of 50 alcohol, drug addiction, and mental health services boards (ADAMH).<sup>1</sup> Each board uses a combination of local, state, and federal dollars to provide services.

OhioMHAS's responsibilities include the following:

- Support, regulate, and monitor local systems of care;
- Provide quality inpatient services;
- Develop strategies to promote mental health and prevent alcohol, drug, and gambling addiction;
- Improve services to children/adolescents;
- Improve linkages between the behavioral health and criminal justice systems;
- Provide training and technical assistance;
- Procure pharmaceuticals for state-run and community-based entities;
- Protect rights of people receiving services.<sup>2</sup>

## **Appropriation summary**

H.B. 33, As Enacted, appropriates \$1,214.0 million in FY 2024 and \$1,145.4 million in FY 2025 for OhioMHAS. Of this amount, 50.4% comes from the GRF, with another 25.4% coming from federal funds. The remaining funds come from Dedicated Purpose funds (13.2%) and Internal Service Activity funds (11.0%).

The Dedicated Purpose Fund (DPF) Group is expected to decrease 40.9% from FY 2024 to FY 2025. This is primarily due to one-time funding in two DPF funds in FY 2024: Fund 4750 appropriation item 336663, Action Resiliency Network; and Fund 5CV3 appropriation items 336521, Monitoring and Treatment ARPA, and 336648, ARPA Pediatric Behavioral Health. The primary factor for the increase in the ISA Fund Group from FY 2023 to FY 2024, is due to expected increases in sales for the Ohio Pharmacy Services.

## FY 2024 and FY 2025 budget highlights

H.B. 33 of the 135<sup>th</sup> General Assembly provides funds for a variety of initiatives. A few of the initiatives impacting OhioMHAS are described below (others are discussed under the appropriate line items).

## Monitoring of recovery housing residences

H.B. 33 requires OhioMHAS to monitor the operation of recovery housing residences by establishing a certification process through OhioMHAS or accepting accreditation, or its equivalent, from specified outside organizations. The bill prohibits, beginning January 1, 2025, the operation of a recovery housing residence unless the residence is certified or accredited, as applicable, or actively working to obtain certification or accreditation. Additionally, the bill requires OhioMHAS to establish and maintain a registry of recovery housing residences and allows the OhioMHAS Director to adopt necessary rules.

H.B. 33 creates a new Dedicated Purpose line item (336661) funded at \$20.7 million in FY 2024 and \$25.8 million in FY 2025 for the 988 Suicide and Crisis Lifeline and mental health treatment and response. The bill transfers cash from the GRF to the 988 Suicide and Crisis Response Fund (Fund 5AA1) to support this appropriation.

#### State of Ohio Action for Resiliency Network

The bill creates a new Dedicated Purpose line item (336663) with an appropriation of \$30.0 million in FY 2024 for the creation of the State of Ohio Action for Resiliency Network and a strategic research agenda and capacity needed to conduct research, clinical trials, direct care, telehealth, data collection, and workforce training pertaining to innovative practices in behavioral prevention, harm reduction, treatment, and recovery. The bill transfers cash from the GRF to the Statewide Treatment and Prevention Fund (Fund 4750) to support this appropriation.

#### Pediatric behavioral health

H.B. 33 appropriates \$50.0 million in FY 2024 in Fund 5CV3 line item 336648, ARPA Pediatric Behavioral Health, to support the following: pediatric behavioral health workforce development, infrastructure improvements at health care facilities to increase access to pediatric behavioral health services (including OhioRISE psychiatric residential treatment facilities), and to improve integration of behavioral health and primary care services. The funds to support this appropriation come from the American Rescue Plan Act.

## **Vetoed provisions**

## **Exchange of Medicaid recipient information with ADAMHS boards**

The Governor vetoed a provision that would have required OhioMHAS and the Ohio Department of Medicaid (ODM) to adopt rules establishing requirements and procedures for the exchange of Medicaid recipient data between ADAMHS boards and ODM, with requirements on how the data was to be exchanged. The provision also required OhioMHAS and ODM to each submit a report with specified information regarding the data exchange requirements and procedures.

## Certification of mental health and drug addiction services

The Governor partially vetoed a provision relating to the certification of mental health and drug addiction services. The budget bill authorizes OhioMHAS to specify by rule the mental health services and alcohol and drug addiction services that must be certified and eliminates a statutory list of specific types of alcohol and drug addiction services that must be certified by OhioMHAS. The Governor vetoed a provision that would have exempted federally qualified health centers and federally qualified health center look-alikes from OhioMHAS's certification requirements for certain mental health and drug addiction services.

## **Transcranial Magnetic Stimulation Program**

The Governor partially vetoed a provision related to the Electroencephalogram (EEG) Combined Transcranial Magnetic Stimulation Program. The bill requires OhioMHAS to continue the program that was previously administered by both OhioMHAS and the Department of

Veterans Services. The Governor vetoed a provision that would have expanded program eligibility to also include civilian employees of the United States Department of Defense and the Central Intelligence Agency and the spouse of eligible individuals.

## Analysis of FY 2024-FY 2025 budget

#### Introduction

This section provides an analysis of the enacted budget funding for each appropriation line item (ALI) in OhioMHAS' budget. For organizational purposes, these ALIs are grouped into five major categories based on their funding purposes. The analysis for an ALI with a lower category or subcategory designation will appear before that for an ALI with a higher category or subcategory designation. That is, the analysis for an ALI with a category designation of C1:8 will appear before the analysis for an ALI with a category designation of C2:1 and the analysis for an ALI with a category designation of C1:8.

To aid the reader in locating each ALI in the analysis, the following table shows the category in which each ALI has been placed, listing the ALIs in order within their respective fund groups and funds. This is the same order the ALIs appear in the MHA section of the budget bill.

In the analysis, each appropriation item's actual expenditures for FY 2023 and enacted appropriations for FY 2024 and FY 2025 are listed in a table. Following the table, a narrative describes how the appropriation is used and any changes affecting the appropriation in H.B. 33. If the appropriation is earmarked, the earmarks are listed and described.

#### **Category 1: Hospital Services**

This category of appropriation line items provides funding to admit, treat, and safely discharge civil and forensic patients in need of inpatient psychiatric treatment. This treatment is provided through a network of six regional psychiatric hospitals which serve as a critical safety net for Ohio's most challenging and complicated cases. This category also supports the operation of Community Support Networks, which perform outpatient activities in support of patients.

Hospital Services is supported by the following four line items. A breakdown of each line item is discussed below.

C1:1: Hospital Services (ALI 336412)

This GRF line item is used to fund the operating budget and inpatient operations of the six state Regional Psychiatric Hospitals. It also supports the Community Support Networks, which provide outpatient activities in support of patients. H.B. 33 of the 135<sup>th</sup> General Assembly increases this appropriation by 12.4% in FY 2024 and 7.3% in FY 2025. This will help support increased costs due to inflation (e.g., utilities and payroll), as well as costs due to other factors such as increases in forensic admissions and reduced revenues from third-party payers. The forensic/civil caseload has an impact on both spending and revenues. Forensic patients are

ordered to receive treatment by the court system and tend to have much longer stays. On the other hand, civil patients typically receive treatment on the advice of a mental health professional and are at the hospital for short-term stabilization services. Most patients are now forensic patients. This change impacts the ability to collect revenues since payers may at times reimburse for this status at a reduced rate.

This line item is used to pay operating expenses for hospital services. Revenue is deposited from various sources in the Mental Health and Addiction Services Operating Fund (Fund 4850), which supports this line item. Those sources include moneys received from private insurance or third-party payers for patients who receive care at a state hospital, monthly reimbursement from a patient's monthly income, reimbursement deposits from patients and liable relatives, workers' compensation reimbursements for patients hospitalized with a work-related injury, and other related revenue.

This line item is used to pay operating expenses for state hospitals. Revenues are generated primarily from the sale of goods and services provided by OhioMHAS, shared service agreements with other agencies or organizations, and conference and licensure fees.

This federally funded line item is used to pay operating expenses for hospital services. Funding for this line item primarily comes from payments for services to patients whose medical insurance provider is Medicare.

#### **Hospital Services overview**

The six regional psychiatric hospitals are located in Athens (Appalachian Behavioral Healthcare), Massillon (Heartland Behavioral Healthcare), Northfield (Northcoast Behavioral Healthcare), Toledo (Northwest Ohio Behavioral Healthcare), Cincinnati (Summit Behavioral Healthcare), and Columbus (Twin Valley Behavioral Healthcare). These specialized facilities provide short-term, intensive treatment to patients in both inpatient and community-supported environments. In addition, these hospitals deliver comprehensive care to patients committed by criminal courts. Civil patients are identified as being a danger to themselves or others due to mental illness, while forensic patients are sent to the hospital by a criminal court due to legal charges. Forensic lengths of stay can vary as the court has the final approval of discharge or conditional release. However, forensic lengths of stay are usually of longer duration. According to OhioMHAS's 2021 Annual Report, roughly 83% of hospital bed days were utilized by forensic patients in that year.

#### Category 2: Community, Recovery, and Prevention Services

This category of appropriation line items includes funds distributed primarily to community behavioral health boards. Basic services include crisis intervention; hospital prescreening; counseling-psychotherapy; drug, alcohol, and gambling addiction treatment services; community support program services; prevention; diagnostic assessment; consultation and education; and residential housing.

This GRF line item is used to distribute funds to the ADAMHS boards and state and local partners to meet locally determined needs. Basic services include crisis intervention, response, and stabilization; medication assistance; hospital prescreening; counseling-psychotherapy; alcohol and drug treatment services; diagnostic assessment; consultation; education and training; community support program services; and residential housing. Boards may use a portion of funds allocated to provide subsidized support for psychotropic medication needs of indigent citizens in the community and to provide subsidized support for medication-assisted treatment costs. There are a number of earmarks under the line item. These are shown in the table below.

This GRF line item is used to pay costs of providing forensic competency to stand trial and not guilty by reason of insanity evaluations for courts of common pleas provided by ten Designated Community Forensic Evaluation Centers. In addition, this line item is used to provide second opinion evaluations for individuals being released from state hospitals. This line item may also be used to, among other things, assist people released from prison in connecting with services in the community, fund behavioral health medications and services in jails, fund forensic monitoring and tracking of individuals on conditional release, provide forensic training, specialized re-entry services to offenders leaving prisons and jails, provide specific grants in support of addiction services alternatives, support specialty dockets, and expand or create new certified court programs. Funds for the Community Transition Program, which provides treatment and recovery supports for people released from prison, will be funded out of this line item in the current biennium. In the previous biennium, these efforts were funded in GRF line item 336423, Addiction Services Partnership with Corrections. Also, funding for line item 336506, Court Costs, has been consolidated into this line item. Item 336506 was used to provide reimbursement to county probate courts for commitment hearings.

H.B. 33 allocates \$5.0 million in each fiscal year to support substance use disorder treatment and to support the administrative expenses of courts and community addiction services providers participating in the program. States are given wide discretion in determining which services will be provided with these funds.

Title XX funds are provided to the community behavioral health boards through an allocation process based on each board's total population, the percentage of the population

below the federal poverty level, and how each board used the funds in the past. The boards then redistribute the funds to local agencies to provide mental health services to clients in the community. Each fiscal year, boards must report details regarding how the grant funds were spent. Examples of services that may be provided with these funds include social services that: help achieve a myriad of goals to reduce dependency and promote self-sufficiency; protect children and adults from neglect, abuse, and exploitation; and help individuals who are unable to take care of themselves to stay in their homes or to find the best institutional arrangements.

According to SAMHSA, target populations and service areas include: pregnant women and women with dependent children, intravenous drug users, tuberculosis services, early intervention services for HIV/AIDS, and primary prevention services. Federal priorities require a minimum of 20% of the funds be spent for primary prevention strategies. The grant allows for 5% of the total award to be used for agency operational expenditures. Primary prevention strategies include: information dissemination; education; alternative, healthy activities to discourage use of alcohol and other drugs; problem identification and referral; and others. In addition, some funds must be spent on women's treatment services per year. For the SAPT Block Grant, Ohio must meet an MOE equal to a multi-year average of state funding for grant-authorized activities. In addition to local boards' allocations to fund treatment services, certain specialized treatment and prevention programs have been funded with SAPT Grant dollars.
