<p><b>ADJCD1 National Guard Benefits</b></p> <p><b>Section: 205.20</b></p> <p>Requires that GRF ALI 745407, National Guard Benefits, be used to reimburse active duty members for life insurance premiums, provide death benefits when an active duty member dies while performing active duty, and administer the associated programs.</p> <p>Permits the transfer of appropriation from any ALI used by the ADJ to this ALI, in order to pay benefits in a timely manner.
