2 (CD-39-DEV) Roadwork Development Fund

Section: 203.09

Specifies that the Roadwork Development Fund (Fund 4W0) is to be used for road improvements associated with economic development opportunities that will retain or attract businesses for Ohio. Directs the Department of Transportation to provide moneys to the Roadwork Development Fund in accordance with applicable guidelines, and to provide assistance to the Department of Development, when required, to bring a project to completion. Also specifies that moneys in the fund may be used in conjunction with Business Development grant awards, provided through appropriation 195-412, Business Development. Finally, specifies that the Director of Budget and Management is to set a cash transfer schedule from the Highway Operating Fund (Fund 002) to the Roadwork Development Fund and to make cash transfers as determined by the schedule.

Fiscal effect: Grants are provided to local governments for public road projects that enhance economic development opportunities. Typical awards range between \$100,000 and \$500,000, but can be as high, or higher, than \$1 million.

Same as the executive, but earmarks \$250,000 in each fiscal year for each of the Transportation Improvement Districts (TID) in Butler, Hamilton, Medina, and Montgomery counties and to the Rossford Transportation Improvement District in Wood County. Districts are authorized to use the payments for any purpose authorized under Chapter 5540. of the Revised Code, including administrative activities and the purchase of property and rights for the construction, maintenance, or operation of a project.

Fiscal effect: In total, \$1.25 million in each fiscal year is earmarked for these TIDs.

Same as the House, except adds Licking, Lorain, and Stark Counties and requires that the earmarked funds be used for specific transportation or highway projects.

Fiscal effect: In total, \$2 million in each fiscal year is earmarked for these TIDs.

Same as the Senate, except removes the earmark for Licking County and replaces it with an earmark of \$250,000 in each fiscal year for Muskingum County. Also, requires that districts that received earmarked funding from this appropriation item (195-629, Roadwork Development) in any prior year use the payments made here for transportation or highway project purposes authorized under Chapter 5540. of the Revised Code. Districts that have not received earmarked funding from this appropriation item in any prior year may use the payments made here for any purpose authorized under Chapter 5540. of the Revised Code, including administrative activities and the purchase of property and rights for the construction, maintenance, or operation of a project.

Fiscal effect: In total, \$2 million in each fiscal year is earmarked for TIDs. TIDs that have received earmarked funding from this appropriation item in the past are more restricted in their use of the funds than TIDs that have never received earmarked funding from this appropriation item.
